
RESOLUTION AUTHORIZING THE CONVEYANCE AND RECORDATION OF A NON-EXCLUSIVE EASEMENT AT THE WAYNE BROWN CORRECTIONAL FACILITY PROPERTY (APN 05-020-22), APPROVING THE EXECUTION OF THE EASEMENT AGREEMENT BETWEEN THE COUNTY OF NEVADA AND PACIFIC GAS AND ELECTRIC COMPANY AND PACIFIC BELL TELEPHONE COMPANY FOR INSTALLATION AND MAINTENANCE OF UTILITIES, AND AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE THE AGREEMENT

WHEREAS, the County of Nevada (County) owns property located at 925 Maidu Ave, Nevada City, CA (APN 05-050-22); and

WHEREAS, Pacific Gas and Electric Company and Pacific Bell Telephone Company dba AT&T California desire to acquire an easement for ingress and egress and utility purposes across a section of land as described in the Easement Deed.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors, of the County of Nevada, State of California, that the Pacific Gas & Electric Company Easement Deed by and between the County of Nevada and Pacific Gas & Electric Company and Pacific Bell Telephone Company dba AT&T California for ingress and egress and utility purposes on County Property located at 925 Maidu Ave, Nevada City, CA, (APN 05-050-22), is hereby approved in the form attached hereto, and the Chair of the Board of Supervisors is hereby authorized to execute the Easement Deed, on behalf of the County of Nevada.

BE IT FURTHER RESOLVED, that the Nevada County Board of Supervisors hereby authorizes the recordation of the Easement Deed by Pacific Gas & Electric Company.

EASEMENT DEED

PM 31231420

COUNTY OF NEVADA, a public body of the State of California,

hereinafter called Grantor, hereby grants to PACIFIC GAS AND ELECTRIC COMPANY, a California corporation, PACIFIC BELL TELEPHONE COMPANY, a California corporation, dba AT&T California, hereinafter collectively called Grantee, the right from time to time to construct, reconstruct, install, inspect, maintain, replace, remove, and use facilities of the type hereinafter specified, together with a right of way therefor, within the easement area as hereinafter set forth, and also ingress thereto and egress therefrom, over and across the lands of Grantor situate in the City of Nevada City, County of Nevada, State of California, described as follows:

(APN 05-020-22)

The parcel of land described in the final order of condemnation, wherein County of Nevada is plaintiff, recorded April 2, 1991 as Document Number 91-08566, Nevada County Records.

Said facilities and easement area are described as follows:

Such anchors, guy wires and cables, guy stubs, and fixtures as Grantee deems necessary located within the strip of land of the uniform width of 10 feet lying 5 feet on each side of the alignment of the facilities as initially installed hereunder. The approximate location of said facilities are shown upon Grantee's Drawing marked EXHIBIT "A" attached hereto and made a part hereof.

Grantor further grants to Grantee the right, from time to time, to trim or to cut down any and all trees and brush now or hereafter within said easement area, and shall have the further right, from time to time, to trim and cut down trees and brush along each side of said easement area which now or hereafter in the opinion of Grantee may interfere with or be a hazard to the facilities installed hereunder, or as Grantee deems necessary to comply with applicable state or federal regulations.

Grantor shall not erect or construct any building or other structure or drill or operate any well within said easement area.

The legal description herein, or the map attached hereto, defining the location of this utility distribution easement, was prepared by Pacific Gas and Electric Company pursuant to Section 8730 (c) of the Business and Professions Code.

The provisions hereof shall inure to the benefit of and bind the successors and assigns of the respective parties hereto.
