#### **\*DEPARTMENT HEAD MATTERS:**

#### Agricultural Commissioner: Chris de Nijs

10.SR 23-4704Acceptance of the 2022 Nevada County Crop and Livestock Report.Accepted.

ACTION TAKEN: Chris de Nijs, Agricultural Commissioner, and Luci Wilson, Agricultural Biologist, provided an overview of the annual report. Staff reported on crop value shifts (including the impact of occurrences such as wine grape double freeze events) as well as the value of nursery products and livestock production. A 10-year summary was provided, including a presentation of overall trends in values. Issues of note for the department included the surge of oriental fruit fly in California, invasive weed control, sustainable agricultural activities, and environmental protection programs. Staff also provided an overview of the Cannabis Supplemental Report. Finally, Commissioner de Nijs thanked local producers for responding to their survey, from which the department was able to gather data for the report.

Board discussion followed, and staff responded to Board questions. Chair Scofield provided an opportunity for public comment and comments were received.

MOTION: Motion made by Supervisor Hoek and seconded by Supervisor Hall to accept the 2022 Nevada County Crop and Livestock Report. On a voice vote, the motion passed unanimously.

#### **Planning Director: Brian Foss**

Informational report regarding the new Nevada County Accessory DwellingUnit (ADU) Guidebook, and acceptance of the Guidebook in substantially the<br/>form attached.Accepted.

ACTION TAKEN: Brian Foss, Planning Director, introduced Marie Maniscalpo, Associate Planner, who provided a presentation. Marie outlined the four-county partnership that went into the Mother Lode ADU Guidebook project. The benefits of ADUs were then explained, including that they allow for multi-generational living, housing for local workers, sources of rental income, support aging in place, and improve property values. In order to support the public to more easily plan and construct ADUs, a guidebook was created. Benefits of the guidebook include that it saves interested parties money and time, and that it acts as a resource for both staff and residents. Mother Lode ADU resources include the PDF guidebook and a website with additional content and features. Highlights of the website include an ADU exercises feature, an ADU cost calculator, and floor plans inspiration.

Marie introduced Brandi Campbell Wood, Principal at Community Planning Collaborative and project manager who helped coordinate all four counties. Discussions of septic, affordability, and pre-approved master plans followed. Supervisor Swarthout requested that Planning report back to the Board in 6 to 12 months on how many people have applied for ADU permits.

Chair Scofield provided an opportunity for public comment and comments were received.

MOTION: Motion made by Supervisor Swarthout and seconded by Supervisor Hall to accept the informational report and accept the Nevada County Accessory Dwelling Unit (ADU) Guidebook. On a roll call vote, the motion passed unanimously.

#### County Executive Officer: Alison Lehman

#### SUMMARY MINUTES

ACTION TAKEN: After a short break. the Board reconvened. Alison Lehman, County Executive Officer, introduced Caleb Dardick, Assistant CEO, Mandy and Stewart. Administrative Analyst. Also present were staff and board members of Pioneer Energy and representatives of Pacific Energy Advisors. Mandy introduced the unfavorable results of the Impact Assessment Study done with Pioneer Energy, then staff and representatives provided details on the background of the project and next steps. A roadmap overview of past and present actions and definitions of an impact assessment study were provided, as well as definitions of several major components in power supply such as energy, renewable energy credits, and resource adequacy. Then the factors considered in the study were explained, such as total eligible customer outlook, customer load comparison, key assumptions, and market prices.

Major conclusions from the study include projected negative fiscal impacts, negative operating margins resulting from expansion, and that market conditions could change in the future that would make expansion beneficial. One option for Nevada County is to end the process and revisit it again in the future, commissioning a new impact assessment study at that time. Another option is to maintain course, meaning that the County commits to absorbing possible rate differences (as Pioneer may still be the less expensive option relative to PG&E) and join the Pioneer board in Spring 2024. Representatives noted that they are looking for general direction from the Supervisors in order to guide Pioneer staff.

Board discussion followed, and staff and representatives responded to questions. Representatives clarified that Grass Valley and Nevada City joined the Pioneer JPA in 2023, but that unincorporated parts of the County will not receive Pioneer service when the other jurisdictions's begins in January 2024; rather service for the unincorporated area will only begin if and when the County joins the JPA. Chair Scofield offered the opportunity for the public to provide comments; no public comment was received.

MOTION: Motion made by Supervisor Hall and seconded by Supervisor Swarthout to pause the Pioneer Community Energy effort and revisit it at a later date. On a roll call vote, the motion passed unanimously.
