



# RESOLUTION No. 26-052

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION APPROVING THE RECOMMENDED PROJECT AND PROGRAM FOR THE 2025 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDING APPLICATION AND AUTHORIZING THE HOUSING AND COMMUNITY SERVICES DEPARTMENT TO COMPLETE THE APPLICATION FOR FUNDING

WHEREAS, the Community Development Block Grant (CDBG) Notice of Funding Availability (NOFA) was released on September 30, 2025, announcing the release of \$27,000,000 in federal funds for community development; and

WHEREAS, the Nevada County Board of Supervisors is committed to community development to promote affordable housing, public services, public improvements, and economic development; and

WHEREAS, Nevada County desires to submit an application under the 2025 CDBG NOFA to progress the Board objective of affordable housing in Nevada County; and

WHEREAS, the CDBG program requires a public meeting to solicit and accept public comment on the use of funds for applications submitted to the program; and

WHEREAS, the Housing and Community Services (HCS) Department held a public meeting on February 12, 2026, in Truckee and on February 11, 2026, in Nevada City to solicit public input on eligible activities under the 2025 CDBG NOFA; and

WHEREAS, public comment was heard and recorded; and

WHEREAS, HCS recommends and seeks approval from the Board of Supervisors on a proposed Project to purchase a building in Eastern County as a public facility for consistent winter sheltering for community members experiencing homelessness and a proposed Program to assist with repair and replacement of mobile homes in mobile home parks in Nevada County to benefit low-to-moderate income households; and

WHEREAS, HCS seeks authorization to apply for funding for this Project and this Program and will bring before the Board of Supervisors the completed application for approval at a later date.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, as follows:

1. Approval of the recommended Project to purchase a building in Eastern County as a public facility for consistent winter sheltering for community members experiencing homelessness and the recommended Program to assist with repair and replacement of mobile homes in mobile home parks in Nevada County for low-to-moderate income households.

2. The Board of Supervisors authorizes the Housing and Community Services Department to apply for the 2025 CDBG funding application, with a completed application to be brought before the Board of Supervisors at a later date.


