



ORDINANCE No. 2500

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

AN ORDINANCE REPEALING SECTION A-II 2.1 OF ARTICLE 2 OF CHAPTER II OF THE ADMINISTRATIVE CODE OF THE COUNTY OF NEVADA REGARDING THE COUNTY'S ADOPTION OF SUPERVISORIAL DISTRICT BOUNDARIES BASED ON UNITED STATES GENERAL CENSUS INFORMATION

NOW, THEREFORE, THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA,
STATE OF CALIFORNIA, ORDAINS AS FOLLOWS:

SECTION 1:

- A. The government of the United States of America performs a general census every ten (10) years.
- B. California Elections Code section 21500 requires that a Board of Supervisors, elected by Districts, "shall adopt boundaries for all of the supervisorial districts of the county so that the supervisorial districts shall be substantially equal in population as required by the United States Constitution".
- C. Any revision to the County Codes of Nevada County incurs expense to the county.
- D. Current Section A-II 2.1 of Article 2 of Chapter II of the Nevada County Administrative Code is amended every ten (10) years to replace legal descriptions of all five (5) Supervisorial Districts.
- E. In order to not incur unnecessary and repeated expenses due to the regular amendment of Section A-II 2.1 of Article 2 of Chapter II, this Ordinance would repeal the entire section listing legal boundaries.
- F. Legal boundaries would be included within a Resolution adopting new boundaries and be available to the public at the Clerk of the Board of Supervisor's office.
- G. The proposed amendment will not be detrimental to the public interest, health, safety, convenience, or welfare of the County.

SECTION II:

Section A-II 2.1 of Article 2 of Chapter II of the Administrative Code of the County of Nevada, is hereby repealed.

SECTION III:

This Ordinance shall take effect and become operative and in force at the expiration of thirty (30) days from and after its passage, conditioned upon the Nevada County Board of Supervisors' approval of a Resolution adopting a County-wide redistricting based on the 2020 census Code, and before the expiration of fifteen (15) days after its passage, it shall be published once, with the names of the Supervisors voting for and against same in the Union, a newspaper of general circulation printed and published in the County of Nevada.
