## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION ACCEPTING THE 2021 EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT IN THE AMOUNT OF \$11,071.00 FROM THE DEPARTMENT OF JUSTICE BUREAU OF JUSTICE ASSISTANCE, TO PURCHASE COMPUTERS AND RELATED PERIPERHAL EQUIPMENT FOR THE SHERIFF'S OFFICE AND AUTHORIZING THE SHERIFF TO SIGN THE AWARD DOCUMENTS AND DIRECTING THE AUDITOR-CONTROLLER TO AMEND THE SHERIFF'S OFFICE FY 21/22 BUDGET (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, the US Department of Justice, Office of Justice Planning, offers a grant program known as the Justice Assistance Grant Program; and

WHEREAS, Nevada County has received notice that the 2021 JAG Formula Grant has been awarded to Nevada County in the amount of \$11,071 and will be used to purchase computers and related peripheral equipment for the Sheriff's Office; and

WHEREAS, the project period is from July 1, 2021 to June 30, 2022, during which time the Sheriff's Office expects to receive and expend the funds during the County FY 21/22.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

- 1) Accepts the JAG Grant, in the amount of \$11,071, from the Department of Justice Bureau of Justice Assistance, to purchase replacement computers and peripheral equipment; and
- 2) Authorizes the Sheriff to sign the Award Documents and certifications; and
- 3) Directs the Auditor-Controller to amend the Sheriff's Office FY 21/22 budget as follows:
