## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION AUTHORIZING EXECUTION OF AMENDMENT 1 WITH NEVADA-SIERRA CONNECTING POINT PUBLIC AUTHORITY FOR THE PROVISION OF SERVICES RELATED TO THE ADMINISTRATION OF EMPLOYMENT SERVICES THROUGH THEIR EMPLOYMENT SERVICES PROGRAM FOR NEVADA COUNTY CALWORKS PARTICIPANTS UTILIZING THE EMPLOYABILITY BARRIER REMOVAL PROGRAM, WORK EXPERIENCE (WEX) AND EXPANDED SUBSIDIZED EMPLOYMENT (ESE) PROGRAMS TO INCORPORATE AN ADDITIONAL NÀVIGATOR AND ADD INCENTIVES TO THE CUSTOMERS FOR PARTICIPATING IN WORK STUDY OR JOB TRAINING AND EDUCATIONAL ACTIVITIES AND AMEND EXHIBIT "B" SCHEDULE OF CHARGES AND PAYMENTS TO REFLECT THE SHIFT IN THE BUDGET LINE ITEMS FOR THE CONTRACT TERM OF JULY 1, 2021 THROUGH JUNE 30, 2022.(RES 21-234)

WHEREAS, on June 15, 2021, per Resolution No 21-234, the Nevada County Board of Supervisors authorized the execution of the Professional Services Contract between the County of Nevada and Nevada Sierra Connecting Point Public Authority for services related to the administration of employment services through their Employment Services program for Nevada County CalWORKs participants utilizing the Employability Barrier Removal Program, Work Experience (WEX) and Expanded Subsidized Employment (ESE) Programs; and

WHEREAS, these services benefit CalWORKs participants by increasing their employability in their efforts to become financially self-sufficient and in addition aids the Department of Social Services in meeting its Federal Work Participation Rate (WPR); and

WHEREAS, the parties desire to amend their Agreement to revise Exhibit "A" Schedule of Services to incorporate an additional navigator and add incentives to the customers for participating in work study or job training activities and amend Exhibit "B" Schedule of Charges and Payments to reflect the shift in the budget line items.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Amendment 1 to that contract by and between the County and Nevada-Sierra Connecting Point Public Authority pertaining to the provision of services related to the administration of employment services for the term of July 1, 2021 through June 30, 2022 in the maximum amount of \$1,422,511 be and hereby is approved and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada.
