

## **RESOLUTION No.**

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

## RESOLUTION TO APPROVE BIDDING DOCUMENTS FOR THE 2022 ROAD REHABILITATION PROJECT 450010, AND AUTHORIZING THE PURCHASING AGENT TO SOLICIT BIDS, AND AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO AWARD AND EXECUTE THE CONTRACT TO THE LOWEST RESPONSIVE BIDDER (NOT TO EXCEED \$1,389,300), OR TO REJECT ALL BIDS; AND AUTHORIZING THE AUDITOR TO AMEND NECESSARY BUDGETS AND ENCUMER THE CONTRACT – DISTRICTS II, IV

WHEREAS, the County of Nevada desires to rehabilitate approximately 4.4 miles of County-maintained roadways and two County Service Area (CSA) locations, to correct asphalt distress and preserve and protect the underlying pavement structure; and

WHEREAS, the Director of Public Works may make adjustments to the roadways listed as necessary; and

WHEREAS, bidding documents have been prepared to accomplish this work; and

WHEREAS, the engineers estimate for the total project is \$1,263,000, plus 10% contingency of \$123,600 for a total not to exceed of \$1,389,300; and

WHEREAS, if all bids exceed the engineers estimate, the staff will either reject the bids or return to the Nevada County Board of Supervisors for approval to award a larger contract; and

WHEREAS, there is enough fund balance and the following maximum budget amendments are necessary to fund the encumbrance in FY 21/22 for each of the following:

CSA 38 Zone 2: 3264-30103-701-4000/521120	\$73,319
CSA 1 Zone 1: 3215-30103-701-4000/521120	\$306,343
Road Engineering: 1114-30104-702-1000/521130	\$996,986

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

- 1. Adopts the bidding documents for the 2022 Road Rehabilitation Project; and
- 2. Authorizes the Chair of the Board of Supervisors to sign the Notice to Contractors; and
- 3. Authorizes the Purchasing agent to solicit bids for the project; and
- 4. Authorizes the Public Works Director to incorporate any final changes into the bid documents before advertising for bids; to award and execute a contract with the lowest responsive bidder, provided the total bid amount does not exceed \$1,263,000, and approve all construction change orders not to exceed a 10% contingency, for a total project cost not to exceed amount of \$1,389,000, or to reject all bids if necessary; execute construction change orders pursuant to Article 9 of the Contract up to the total continency amount; and

4. Authorize the Auditor to amend the budgets up to the amounts listed above and encumber the contract for the bid amount including a 10% contingency.
