## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING EXECUTION OF AMENDMENT NO. 2 TO THE CONTRACT BETWEEN COUNTY OF NEVADA AND TURNING POINT COMMUNITY PROGRAMS, INC. FOR EXPANSION OF 24/7 STAFFING FOR UP TO 6 ADDITIONAL UNITS OF PERMANENT SUPPORTIVE HOUSING, INCREASING THE MAXIMUM CONTRACT AMOUNT TO \$4,145,010 FOR FY 21/22 (AN INCREASE OF \$89,628), REVISING EXHIBIT "A" SCHEDULE OF SERVICES TO REFLECT A CHANGE IN STAFFING AND SERVICES, AND REVISING EXHIBIT "B" SCHEDULE OF CHARGES AND PAYMENTS TO REFLECT THE INCREASE IN THE MAXIMUM CONTRACT PRICE FOR FISCAL YEAR 21/22 (RES 21-259) (RES 21-509)

WHEREAS, on June 22, 2021, per Resolution 21-259, the Nevada County Board of Supervisors approved the renewal contract with Turning Point Community Programs, Inc. to provide Adult Assertive Community Treatment Programs (AACT) as a component and consistent with Nevada County's approved Mental Health Services Act (MHSA) Community Services and Supports (CSS) Plan, which was amended on December 14, 2021 per Resolution 21-509; and

WHEREAS, the Contractor's AACT Team model is a multi-disciplinary approach to providing community-based treatment, outreach, rehabilitation, and support services to individuals with serious mental illness, and the Team operates 24-hours, 365 days a year to provide flexible crisis intervention and wraparound services that are tailored to address each eligible participant's unique and changing needs; and

WHEREAS, the Contractor will continue to implement and monitor a Supportive Independent Living Program for Medi-Cal beneficiaries that serves a critical ongoing need for providing safe, supported housing in the least restrictive environment for appropriate clients; and

WHEREAS, the vision of Nevada County Behavioral Health is to build and support healthy futures in which people with a serious mental illness (SMI) are able to achieve health, wellness, and recovery through the development of integrated health care services and identification of a person-centered health care home; and

WHEREAS, the parties desire to amend their agreement to 1) increase the Maximum Contract Price to \$4,145,010 (an increase of \$89,628); 2) revise Exhibit "A" Schedule of Services to reflect the expansion of 24/7 staffing for up to 6 additional units of permanent supportive housing, and 3) revise Exhibit "B" Schedule of Charges and Payments to reflect the increase in the maximum contract price.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Amendment No 2 to the Professional Services Contract by and between the County of Nevada and Turning Point Community Programs, Inc. pertaining to the provision of: Adult Assertive Community Treatment (AACT) Program

Services as a component of the County's Mental Health Services Act (MHSA) Community Services and Supports (CSS) Plan; increasing the maximum contract in the amount to \$4,145,010 (an increase of \$89,628), revising Exhibit "A" to reflect a change in service requirements and revising Exhibit "B" to reflect an increase in the maximum Contract price for Fiscal Year 2021/22 be and hereby is approved.
