**MEETING DATE:** May 24, 2022  
**TO:** Board of Supervisors  
**FROM:** Trisha Tillotson, Acting Director of Public Works  
**SUBJECT:** Resolution to award the contract for the River Fire Tree Removal Safety Project to Bay Area Tree Specialists for a total amount of \$30,850.00 under County project number 440830 and authorizing the Auditor Controller to encumber the contract – District II.

**RECOMMENDATION:** Approve the attached resolution.

**FUNDING:** This project will be initially funded by the Road Fund, which will then request a reimbursement from Federal Emergency Management Agency (FEMA), California Office of Emergency Services, and any unreimbursed portion will be compensated to the Road Fund by General Fund, as per Resolution 22-134.

**BACKGROUND:** On March 22, 2022, the Nevada County Board of Supervisors approved Resolution 22-134 to authorize the Purchasing Agent to solicit bids for the River Fire Tree Removal Safety Project. These bids were opened on April 19, 2022, and are listed below:
