OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION TO AWARD THE CONTRACT FOR THE STORM DEBRIS REMOVAL PROJECT TO ROBINSON ENTERPRISES, INC. FOR A TOTAL AMOUNT OF \$98,059.50 UNDER COUNTY PROJECT NUMBER 440836 AND AUTHORIZING THE AUDITOR CONTROLLER TO ENCUMBER THE CONTRACT – DISTRICT ALL

WHEREAS, the County experienced a storm event in December of 2021, that caused significant damage including the downing of an unprecedented number of trees and both County and non-County resources worked to move debris to a temporary location at Rise Mine; and

WHEREAS, the Nevada County Board of Supervisors approved Resolution 22-133 to authorizing the Purchasing Agent to solicit bids for the Storm Debris Removal Project that would consist of removal of the debris currently stored at the Rise Mine site; and

WHEREAS, although Resolution 22-133 also authorized the Director of Public Works to award and execute the Contract, by this new Resolution, award will be authorized directly by the Board of Supervisors, and this Contract will be executed directly by the Chair of the Board of Supervisors; and

WHEREAS, bids were opened on April 18, 2022, with the low bid being The Professional Tree Care Company at \$36,900.00; and

WHEREAS, on April 19, 2022, The Professional Tree Care Company officially withdrew their bid; and

WHEREAS, the next lowest qualified bidder is Robinson Enterprises, Inc. at \$89,145.00; and

WHEREAS, the bid price is \$89,145.00, plus a 10% contingency of \$8,914.50 for a total of \$98,059.50; and

WHEREAS, the low bidder met all of the bid submittal requirements; and

WHEREAS, work for the project is scheduled to begin in June 2022; and

WHEREAS, \$78,448 (80%) of cost will be reimbursed by the Cal Fire Storm Debris/Stockpile and Tree Removal Grant 5GA21115 and the remaining \$19,612 (20%) of cost will initially be funded by the Road Engineering budget; and

WHEREAS, County staff will continue to explore reimbursement opportunities through the California Disaster Assistance Act and any unreimbursed portion may later be compensated to the Road Fund by the General Fund, as per Resolution 22-133; and

WHEREAS, Resolution 22-133 amended the Road Engineering budget and budget is available to encumber this project for Fiscal Year 2021-22.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

1. Approves the award contract to the low bidder, Robinson Enterprises, Inc. in the amount of \$89,145.00, plus a 10% contingency of \$8,914.50 for a total of \$98,059.50.

2. Authorizes the Chair of the Board of Supervisors to execute on behalf of Nevada County a Standard Long form Public Works contract between Nevada County and Robinson Enterprises, Inc., upon receipt of the Payment Bond and Performance Bond by the Director of Public Works and approval and acceptance of the Certificate of Insurance by the Risk Manager.

3. Authorizes the Auditor Controller to encumber the contract:
