**SUBJECT:** Resolution to award the contract for the Storm Debris Removal Project

to Robinson Enterprises, Inc. for a total amount of \$98,059.50 under County project number 440836 and authorizing the Auditor Controller

to encumber the contract. - Districts All

**RECOMMENDATION:** Approve the attached resolution.

<u>FUNDING</u>: The Storm Debris Removal Project will be funded \$78,448 (80%) by Cal Fire Storm Debris/Stockpile and Tree Removal Grant 5GA21115. The remaining \$19,612 (20%) will initially be funded by Road Engineering. Reimbursement from the California Disaster Assistance Act will continue to be explored and any unreimbursed portion to Road Engineering may later be compensated by the General Fund, as per resolution 22-133.

BACKGROUND: In December 2021, Nevada County experienced a storm event that caused significant damage throughout the County including the downing of an unprecedented number of trees. Due to efforts of a number of County and Non-County resources, downed trees and vegetation were removed from County maintained roadways to a temporary location at Rise Mine. On March 22, 2022, The Nevada County Board of Supervisors approved Resolution 22-133 to authorize the Purchasing Agent to solicit bids for the Storm Debris Removal Project. The project work to be performed consisted of the removal of trees, limbs, and storm debris material attributable to the December 2021 storm event. Debris is currently stockpiled at the Rise Mine site in Grass Valley. Resolution 22-133 also authorized the Director of Public Works to award the Contract. Award of the Contract will now be authorized directly by the Board of Supervisors and the Contract will be executed by the Chair of the Board of Supervisors. These bids were opened on April 18, 2022, and were as follows:
