

Consolidated User Fee Update

Fiscal Year 2022/23

Background

- Previous direction from the Board to consolidate and streamline adoption of Nevada County Departmental User Fees
- First consolidated User Fee adoption in FY 2019/20 (Resolution 19-242)
 - included a Consumer Price Index mechanism for updating fees annually (not including statutory fees)
 - Fee Schedules included: Clerk of the Board, Community Development Agency, Information and General Services, Probation, Registrar of Voters (Elections) and Social Services (Public Guardian)
- Amendments to Resolution 19-242 in FY 2020/21 and FY 2021/22 added additional fee schedules
 - FY 2020/21: Animal Control and Shelter, Sheriff, Library, and Treasurer-Tax Collector
 - FY 2021/22: Clerk Recorder, Geographic Information Systems (GIS), Public Health Vital Records

FY 2022/23 Proposed Fee Update FY 2022/23 proposed fee update includes:

- New resolution to adopt full consolidated list of fee schedules, and adds the Assessor's fee schedule (updated, full review)
- Updates Fee Schedules for CDA (full review), Clerk of the Board (full review), Public Health Vital Records (statutory updates only), Treasurer-Tax Collector (CPI only)

FY 2022/23 Proposed Fee Update, con't

- All fees were reviewed by the User Fee Review Group (CEO, Auditor, County Counsel)
- All fees are included in each department's FY 22/23 Proposed Budget and have been reviewed by the Budget Subcommittee

*Also rescinds Resolutions 19-242 as amended by 21-180 (current Consolidated Fee Reso, and 98-263 (current Assessor Fee Reso) Fee Development and Review Process

- Fee Studies and proposed updates were reviewed by the User Fee Review Group (UFRG)
- Fee Updates are considered reasonably necessary to recover the cost of providing service / enforcing regulations for which a fee is levied
- Fees based on actual cost and hourly rates with consideration of statutory requirements
- Include a CPI annual adjustment factor if applicable

Annual Fee Updates (CPI Adjustment)

- Certain fees (non-statutory and where applicable) will be automatically updated in the two fiscal years following adoption of the fees
- Annual adjustment based on yearly increases of Urban Wage Earners and Clerical Workers in California as published by California Department of Industrial Relations
- Provides for periodic reviews to minimize any deviations between CPI and Actual cost
 - Also, allows for CPI adjustment to be waived if recommended by UFRG and approved by Board
- Departments with CPI adjusted fees are the Assessor, Clerk
 of the Board, CDA, and Treasurer /Tax Collector
- If statutory fees change, they are automatically updated through the duration of the resolution

Assessor

- Last Updated in 1998
- Fees generally collected for documents related to the County tax roll, annexations, maps and other documents, and research services.
- Fees were reviewed and revised based on current processes and some outdated fees were eliminated
- Automatic annual CPI adjustment will apply to hourly fees

Clerk of the Board

- Last Full Update in 2019/20
- Annual CPI adjustments have been applied since 2019/20
- Fees generally collected paper and electronic copies of documents, transcription, and efforts related to Assessment Appeals
- Automatic annual CPI adjustment applies to certain fees (generally hourly fees)


- Last Full Update in 2019/20
- Annual CPI adjustments have been applied since 2019/20
- Includes fees for all CDA departments (Ag Commissioner, Building, CDA Admin, Cannabis Compliance, Code Compliance, Surveyor, Planning, Environmental Health, and Public Works)
- Automatic annual CPI adjustment generally applies

Other Changes

- Public Health Vital Records includes statutory changes implemented by the State
- Treasurer-Tax Collector includes automatic annual CPI adjustments
- Other fees remain unchanged

Rate Study included:

- Analyze Direct and Indirect Costs for Each Dept
- Review 3 years of Time Tracking and Time Studies to determine Productive Hours for dept staff
- Review Dept Fund Balance
- Engagement with Development Community & Associations



- Dec 2021 CPI (Consumer Price Index) CA = 7.0%
- Dec 2021 CCI (Construction Cost Index) for Bay area= 8%
- CDA proposed average increase is 5.8%.


