## **EXHIBIT A**

## Sec. G-IV 3.A.8 Parking Prohibitions

- A. The Director of the Department of Public Works of the County of Nevada is hereby authorized and instructed to erect or cause to be erected, appropriate signs on various County roads and highways described in Section G-IV 3.A.7, giving notice of the prohibition of parking as declared and established by this Section.
- B. No vehicle shall be parked upon the County right-of-way for Boreal Ridge Road for 0.2 miles beginning at the Interstate 80 West off-ramp from November first through April thirtieth; vehicles parked upon County right-of-way during this period will be towed away at owner's expense. At all other times, no vehicle shall be parked at any time in designated no parking zones upon the County right-of-way for Boreal Ridge Road for 0.2 miles beginning at the Interstate 80 West off-ramp.
- C. No vehicle shall be parked at any time upon the paved roadway, and in designated no parking zones upon the County right-of-way, and between 10p.m.-5a.m. where indicated by "NO PARKING 10p.m.-5a.m." signs, on Coyote Street from North Bloomfield-Graniteville Road 0.528 miles south to the Nevada City limit.
- D. No vehicle shall be parked at any time upon the traveled portion of Dog Bar Road from the bridge crossing Bear River to Magnolia Road. No vehicle shall be parked at any time in designated no parking zones upon the County right-of-way for Dog Bar Road from the bridge crossing Bear River to Magnolia Road.
- E. No vehicle shall be parked upon the County right-of-way for Donner Lake Road for 0.05 miles from Billy Mack Road to the Interstate 80 West off-ramp from November first through April thirtieth; vehicles parked upon County right-of-way during this period will be towed away at owner's expense. At all other times, no vehicle shall be parked at any time in designated no parking zones upon the County right-of-way for Donner Lake Road for 0.05 miles from Billy Mack Road to the Interstate West 80 off-ramp.
- F. No vehicle shall be parked at any time upon the traveled way of Donner Pass Road from the Interstate 80 West off-ramp to the town limit of the Town of Truckee.
- G. No vehicle shall be parked at any time in designated no parking zones upon the County right-of-way for Maybert Road from Washington Road 2.93 miles west to the Canyon Creek Bridge.
- H. No vehicle shall be parked at any time upon the traversed portion of Newtown Road from State Highway 49 to 500 feet southwest on Newtown Road.
- I. No vehicle shall be parked at any time upon County right-of-way in designated no parking zones on North Bloomfield-Graniteville Road, both sides of the Edwards Crossing Bridge.
- J. No vehicle shall be parked at any time upon the County right-of-way in designated no parking zones, and between 10p.m.-5a.m. where indicated by "NO PARKING 10p.m.-5a.m." signs, on Old Downieville Highway from Cedro Road to the Nevada City limit and Champion Road from Newtown Road to Old Downieville Highway. - K. No vehicle shall be parked at any time in designated no parking zones upon the County right-of-way for Pleasant Valley Road from 2,500 feet south of the Yuba River Bridge on

Pleasant Valley Road at the South Yuba State Park to 1,500 feet north of the Yuba River Bridge on Pleasant Valley Road at the South Yuba State Park.

- L. No vehicle shall be parked at any time upon County right-of-way in designated no parking zones on Purdon Road, both sides of Purdon Bridge.
- M. No vehicle shall be parked at any time in designated no parking zones on the County right-of-way for Relief Hill Road from Gaston Road 0.466 miles east to the end of pavement.
- N. No vehicle shall be parked at any time upon the traveled way of the Soda Springs Road from Donner Pass Road thence southerly to the Nevada-Placer County boundary.
- O. No vehicle shall be parked between the hours of 8 a.m. and 4 p.m. on school days upon the County right-of-way on Via Vista between Ridge Road and 200 feet east of its intersection with Echo Ridge Drive.
- P. No vehicle shall be parked at any time in designated no parking zones upon the County right-of-way for Washington Road from Maybert Road to 1,500 feet west of the South Yuba River Bridge on Washington Road."
