# American Rescue Plan Act (ARPA) Summary

- \$19.4M County Allocation
- \$9.67 received on June 10, 2021, remaining funds expected July 2022
- Funds must be fully obligated by December 31, 2024
- Expenditures can be used for:
  - Respond to the public health emergency and address its negative economic effects
  - Provide premium pay for essential workers
  - Provision of government services
  - Invest in water, sewer, and broadband infrastructure

# Board Direction for ARPA Expenditure Plan

## Policy Direction (4/27/2021)

- Provide support to the community to encourage economic recovery and resiliency
- Continue to fund costs and revenue loss related to the COVID-19 pandemic
- Focus on outcomes, including BOS priorities where possible
- Leverage this one-time funding to provide long term benefits to the County
- Avoid funding items that could be funded by other state or federal sources
- Be strategic and measured, as we have a longer time horizon to spend the dollars
- Remain flexible, as County needs and Federal guidance may evolve over time

# Outdoor Visitor Safety Fund Grants

Nevada County to fund projects or programs that respond to the negative economic impacts of the COVID-19 pandemic with a project that will increase resiliency and promote health and safety at highly impacted outdoor recreation destinations.

Nevada County experienced a significant increase in visitation to outdoor recreation destinations during the pandemic.

This project will address unmet need(s) at an outdoor recreation site to promote community health and safety, economic development, and resilience; and furthers the ARPA priority of “2.22: Strong Healthy Communities: Neighborhood Features that Promote Health and Safety”.

# Two Strategies

## 1. Address emergent needs

Targeted smaller grant agreements to enhance existing programs that address emergent health and safety needs.



## 2. Support sustainable change

New competitive grant program offering grants up to \$200,000 for leveraged projects.





# River and Trail Ambassadors Addressing Emergent Health and Safety needs

1. Bear Yuba Land Trust Trail Keepers
2. South Yuba River Citizens League River Ambassadors
3. Truckee Trails Trail Host Ambassadors (plus temporary portable restroom management)





# Grant Program Overview

- Up to \$850,000 made available
  - \$450,000 ARPA, \$400 General fund
- Grants capped at \$200,000
- The primary focus will be on infrastructure projects located at major trailheads and river crossings in Nevada County
- Eligible Entities:
  - Nonprofits
  - Businesses
  - Special Purpose Districts
  - State and Federal entities may be eligible depending on available general fund monies.

# Application Process: 2 Steps

*Step 1:* Brief concept proposal describing the project.

*Step 2:* Full project application, addressing:

- The community need addressed, and the impacts of COVID-19;
- How the project directly responds to the negative economic impacts of the pandemic;
- How the project will provide ongoing community benefits with impactful, measurable outcomes;
- How the project leverages additional partnerships, funding, and other resources as part of their proposal;
- Management capacity and measurable outcomes—demonstrate their capacity to manage, implement, measure and report on the grant; and
- Budget and Financials.





# Evaluation

**The Panel:** An evaluation panel of 3 staff and two community members review and scored responses.

Panel was advisory to CEO, who made final recommendation.

**Step 1: Concept Proposals:** The County received 19 concept proposals from 10 different entities; 13 proposals from 9 entities were invited to submit a full proposal.

**Step 2: Full project application(s).** The County received 6 full applications from 5 different entities. All six applications are recommended for full funding requested.

# Recommended Action

**Adopt the 9 resolutions authorizing these grant agreements.**

Three targeted grant agreements:	\$16,705
Six grant agreements from RFP response:	\$361,965
<u>Total:</u>	<u>\$415,470</u>
