RESOLUTION APPROVING EXECUTION OF AMENDMENT NO. 1 TO THE CONTRACT WITH INTEGRATED PSYCHIATRIC SOLUTIONS, INC. FOR THE PROVISION OF MENTAL HEALTH SERVICES, TO INCREASE THE MAXIMUM CONTRACT PRICE FROM \$45,000 TO \$65,000 (AN INCREASE OF \$20,000) AND REVISE EXHIBIT "B", SCHEDULE OF CHARGES AND PAYMENTS TO REFLECT THE INCREASE IN THE MAXIMUM CONTRACT PRICE FOR THE TERM OF JULY 1, 2021, THROUGH JUNE 30, 2022 (PESP4362)

WHEREAS, on September 16, 2021, per Purchasing Order PESP4362, the Nevada County Purchasing Agent approved execution of the Professional Services Contract with Integrated Psychiatric Solutions, Inc. for the provision of mental health services; and

WHEREAS, the parties desire to amend their Agreement to increase the contract price from \$45,000 to \$65,000 (an increase of \$20,000) and amend Exhibit "B" Schedule of Charges and Payments to reflect the increase in the maximum contract price.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Amendment No. 1 to that contract by and between the County and Integrated Psychiatric Solutions, Inc., with a contract term of July 1, 2021, through June 30, 2022, in the maximum amount of \$65,000, be and hereby is approved, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Contract on behalf of the County of Nevada.

AMENDMENT #1 TO THE CONTRACT WITH INTEGRATED PSYCHIATRIC SOLUTIONS, INC. (PESP4362)

THIS AMENDMENT is executed this 12th day of April by and between INTEGRATED PSYCHIATRIC SOLUTIONS, INC., hereinafter referred to as "Contractor" and COUNTY OF NEVADA, hereinafter referred to as "County." Said Amendment will amend the prior Agreement between the parties entitled Professional Services Contract, executed on September 16, 2021 per Purchase Order No. PESP4362; and

WHEREAS, the Contractor operates services related to mental health; and

WHEREAS, the parties desire to amend their Agreement to increase the contract price from \$45,000 to \$65,000 (an increase of \$20,000) and revise Exhibit "B" Schedule of Charges and Payments to reflect the increase in the maximum contract price.

NOW, THEREFORE, the parties hereto agree as follows:

- 1. That Amendment #1 shall be effective as of February 1, 2022.
- 2. That Maximum Contract Price, shall be amended to the following: \$65,000.
- 3. That the Schedule of Charges and Payments, Exhibit "B" is amended to the revised Exhibit "B" attached hereto and incorporated herein.
- 4. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.

CONTINGENCY

Contract maximum is contingent and dependent upon the County's annual receipt of anticipated State/Federal Funds for contract services.

BILLING AND PAYMENT

- Cost of services rendered identifying total direct costs
- Billing period covered
- Contract Number assigned to the approved contract
