SUBJECT:

Resolution approving the award of a contract to Maxwell Asphalt Inc, for pavement rehabilitation of Taxiway A and Ramps 1, 2 and 5 in the maximum contract price of \$297,448, at the Nevada County Airport, authorizing the Chair of the Board to execute the contract, and amends the Airport 22/23 budget (4/5 affirmative vote)

RECOMMENDATION: Adopt the Resolution

FUNDING: The pavement rehabilitation of Taxiway A and Ramps 1, 2 and 5 at the Nevada County Airport is estimated to cost \$400,406. The FAA has provided a grant in the amount of \$360,366. CALTRANS Division of Aeronautics is expected to provide \$18,018 in a matching grant. The Airport's maximum cost will be \$22,022, which will be paid out of the Airport Enterprise Fund. Funding is included in the FY2022-23 Airport budget. There is no impact on the General Fund.

BACKGROUND: Board of Supervisors Resolution 22-085 approved construction bid documents and specifications for solicitation of bids for pavement rehabilitation of Taxiway A and Ramp 2, with two bid alternates at the Nevada County Airport. Four bids were received, and the lowest responsible bidder was Maxwell Asphalt Inc, at \$270,406.25, plus 10% contingency. The contract has been approved by the FAA for award to Maxwell Asphalt Inc. Board of Supervisors Resolution 22-157 authorized the application for an FAA grant. There is a Resolution proposed on this agenda to accept the FAA grant in the amount of \$360,366 for the pavement rehabilitation. These funds will be encumbered by the FAA in anticipation of the County awarding the contract to Maxwell Asphalt Inc. in addition to the utilization to pay for the Airport Engineer and project management costs. There is also a Board of Supervisors Resolution on this agenda to request the matching grant from CALTRANS which cannot occur until the FAA grant offer is accepted. The Airport Commission has reviewed this project and supports the contract.
