**SUBJECT:** **Resolution to Award the Contract for the 2022 Nevada County Annual Striping Project, County Project No. 426640, to Sierra Traffic Markings, Inc. for a Total Amount of \$272,503.17 and Authorizing the Auditor-Controller to Encumber the Contract – All Districts**

**RECOMMENDATION:** Approve the attached resolution.

**FUNDING:** The project is budgeted in the fiscal year 2022/23 Road Maintenance budget. Funding is provided by Highway User Tax Account (HUTA) and Regional Surface Transportation Program (RSTP) funds. There is no impact to the County's General Fund and no budget amendment is needed.

**BACKGROUND:** On March 22, 2022, the Nevada County Board of Supervisors adopted Resolution No. 22-135 approving the plans, specifications and cost estimate for the subject project and instructed the Nevada County Purchasing Division to advertise for bids. The bids were opened on April 27, 2022, and are listed below:

It is recommended that the contract be awarded to the low bidder, Sierra Traffic Markings, Inc. at the bid price of \$247,730.15 plus a 10% contingency of \$24,773.02 for a total of \$272,503.17.

This project involves striping of approximately 70 miles of County roads. Work is scheduled to begin in September 2022 and be completed within 35 working days as allowed for in the contract.
