SUBJECT: Resolution Adopting the Veteran Sign Project for a Total Amount Not to

Exceed Three Thousand (\$3,000) Dollars.

RECOMMENDATION: Adopt the Resolution.

<u>FUNDING</u>: The Veteran Sign Project will be funded through the Fiscal Year 2022-23 Roads Maintenance budget. A budget amendment is not necessary and there is no impact to the General Fund. Initial cost of sign placement is less than or equal to three thousand (\$3,000) dollars.

BACKGROUND:

Nevada County Public Works, in conjunction with Nevada County Veterans Services, is proposing to add the phrase "Where We Honor Veterans" to "Nevada County Line" signs, in prominent, well-traveled locations, throughout the County. Per Streets and Highways Code – Section 1978 a resolution must be adopted to place such signs. Once signs are installed the signs will be incorporated into the annual sign inventory and maintained with other County signage.

Since 6 of the 7 proposed signs will be in the Caltrans right-of-way a resolution must be adopted by the Nevada County Board of Supervisors in order to receive an encroachment permit from Caltrans to install and maintain said signs. This permit has no cost associated with it and would be provided by Caltrans district #3.

Signs will replace existing "Nevada County Line" signs at seven locations.
