Dear Board of Supervisors,

The Nevada County Climate Action Now group strongly supports the sales tax proposal outlined by Caleb Dardick at a recent Firewise Coalition meeting to provide sustainable funding for disaster preparedness. Natural disaster threats are a significant problem for our County, and currently no earmarked source of funds exists to support efforts to prepare. Many projects rely on grant funding and the assistance of non-profits like FireSafe who also must secure grant funds on top of their management of vegetation fuel reduction and defensible space advisory service duties.

Wildfire in California is a significant carbon emission source and effectively negates many of the efforts taken to reduce greenhouse gas emissions. Plus, destruction of our forests removes important carbon sinks, seriously damages our precious watersheds in the face of ongoing drought and requires vast amounts of fossil fuels to fight fires and provide emergency power when PSPS events occur.

Most parts of Nevada County have an extreme wildfire risk and additional resources are needed to address the problems before disasters strike. Having time, resources and expertise to deliberately and intelligently prepare for a safer county, while protecting our important environmental assets, is a prudent use of funds. We applaud the County's foresight in proposing a sales tax provision on the ballot. While we realize it is difficult to get tax on parcels, a sales tax may be a more widely accepted approach. However, we trust the county would find ways to offset the impact of a regressive sales taxes on lower income residents.

Thank you for considering this important step to obtain voter approval to protect the life, property and resources of our community.



Dear Supervisors:

This letter is intended to support placing the half cent sales tax for wildfire mitigation on the November ballot.

A modest sales-tax measure could be used to support the long-standing BOS goal of reducing wildfire risk in Nevada County. The County has significantly increased its efforts in recent years, and the results are appreciated. But more must be done. The proposal in front of you is the result of three years of community conversations. It is the collective best-thinking about the way to raise funds to tackle needed projects in a thoughtful, evidence-based way.

Placing this item in front of voters, who have been polled multiple times during this process, allows this community to participate differently. Many residents have already shown their interest in wildfire mitigation by clearing their property, volunteering their time on fire-related causes, and attending community meetings. We hope you'll give them the opportunity to support a much-needed stable funding source. Estimates show that \$12 million would be available for high priority projects, perhaps more if some of the funds are used to secure additional matching grants.

If given the chance, we will wholeheartedly support this effort with our vote. We believe it is pivotal that expenditures will be directed by an all-volunteer group of technical experts and citizen representatives, and that all expenses will be audited and reported to the public at least annually.

Dear Supervisors,

On behalf of Greater Champion Firewise Community, I am writing to urge you to let the voters decide in November whether to enact the Wildfire Prevention, Emergency Preparedness, and Disaster Readiness Measure.

Wildfire is an existential threat to Nevada County. CaFire classifies our area in its highestrisk-category, "very high fire hazard". Scientists analyzing the Camp Fire have pointed specifically to Nevada City as a town with characteristics similar to those of Paradise. We are in a perilous position created by the confluence of geography, drought, hazardous vegetation, and older, closely spaced homes.

Like many other Nevada County Firewise groups, Greater Champion works year-round to improve fire safety. We collaborate with public agencies and other Firewise groups, but there is much more that needs to be done, much of it beyond the scope of a neighborhood Firewise group. Even if every house had perfect defensible space, we still would need to address community-wide safety issues. We need the County to lead the way in large-scale projects, and we need to increase the number and scale of such projects. This measure would provide the funding to undertake them.

As residents we are alarmed by the danger we face. We urge County leaders to embrace this challenge and let the voters decide on this measure in November.
