Today I heard that the County of Nevada Board of Supervisors will put on your August 9th Agenda <u>Ready Nevada County: Preparing for the Future</u>. The proposed funding mechanism for this measure is a 1/2 cent general sales tax with the objective to place this measure on the November Ballot.

We, the Nevada County Restoration Coalition state clearly and specifically that <u>we ARE NOT in</u> <u>FAVOR</u> of the proposed method of funding this measure by creating a general sales tax or the *measure as it is written* we ASK YOU our Supervisors to "table" this measure until we can have discussion with the community.

Increasing all Sales Tax in Nevada County by 1/2 <u>cent RAISES the sales tax from 8.5% to 9%. County</u> sales tax, now at 7.5% becomes 8%.

It is our desire to keep the dollars local, and the proposed sales tax increase may drive folks to Placer County where the sales tax is 7.75% AND the effect this tax would impact every business and every household.

We are currently experiencing inflation, and a pending recession. This 1/2 cent tax increase adds an unnecessary burden and costs to everyday purchases as well as an increase in construction material costs that directly affects all levels of housing. As the cost per square foot rises, so will home insurance.

We Nevada County Restoration Coalition ASK YOU our supervisors to "table" this measure and engage in a robust discussion with community partners and community stakeholders to determine the best possible method of achieving the worthy objectives of this measure.

Reasons why we oppose this:

• "Monies raised through a general tax are considered General Fund revenue, and thus available for all General Fund programs. They cannot legally be bound to a predetermined use, such as wildfire safety." Richard Anderson, former District 5 Supervisor, an excerpt from his letter of Public Comment to the Town of Truckee Council on this proposed 1/2 cent sales tax increase.

- No economic impact study has been done.
- No public engagement to date.
- Lack of specificity regarding ballot and program language and detail.
- There is no sunset date proposed in this measure.
- This measure would directly increase housing, workforce housing, and affordable housing construction costs.
- "Response" (firefighters, fire equipment) is not included in this measure.

• According to our Fire Chief, Mark Buttron, the measure as written would negatively impact the Fire Districts.
