



RESOLUTION No. 22-430

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION ADOPTING THE VETERAN SIGN PROJECT FOR A TOTAL AMOUNT NOT TO EXCEED THREE THOUSAND (\$3,000) DOLLARS

WHEREAS, effective January 1, 2007, California Streets and Highway Code (SHC) implemented Section 1978; and

WHEREAS, SHC Section 1978 allows the addition of the statement "Where We Honor Veterans" to County signs at or near county lines; and

WHEREAS, the addition or modification of such signs is to be paid for by the Roads Maintenance Fiscal Year 2022/23 budget and maintained by that same County budget years going forward; and

WHEREAS, upon the adoption of this resolution by the Board of Supervisors, said signs may be placed and added to the County Annual Sign Inventory; and

WHEREAS, Nevada County Veterans Services in Conjunction with Nevada County Department of Public Works has developed a list of locations and plan for implementation of such signs per attached Exhibit A; and

WHEREAS, the Veteran Sign Project will install seven (7) signs that will be paid for and installed by the Nevada County Road Maintenance Division at a cost not to exceed three thousand (\$3,000) dollars; and

WHEREAS, there is sufficient budget in Road Maintenance and budget amendment is not necessary.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

1. Approves the Veteran Sign Project to be implemented and paid for through the Roads Maintenance Budget.
