### OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING THE GRANT AWARD AGREEMENT WITH SOUTH YUBA RIVER CITIZENS LEAGUE (SYRCL) FOR \$46,371 FOR THE "OUTDOOR VISITOR SAFETY FUND GRANT" FOR THE GOLDEN QUARTZ PICNIC AREA VAULT TOILETS FUNDED BY THE AMERICAN RESCUE PLAN ACT (ARPA) AND AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE GRANT AGREEMENT WITH AWARDEE

WHEREAS, the American Rescue Plan Act of 2021 (ARPA) is a \$1.9 trillion economic stimulus package passed by Congress and signed by President Joseph Biden on March 11, 2021 in response to the ongoing COVID-19 pandemic and associated economic challenges. ARPA included \$350 billion in State and Local Aid, which included \$65.1 billion in direct funding to counties. Based on US Treasury allocations, Nevada County has been allocated \$19,376,239 in funding; and

WHEREAS, on April 27, 2021, staff brought a preliminary ARPA Expenditure Plan to the Board for direction. The plan included a recommendation to allocate 30% of ARPA funds (\$5.8M) to "Community & Economic Resiliency" projects. This included one loan program and four grants, including the "Outdoor Visitor Safety Fund" program, which was allotted between \$800,000-\$1,000,000 for improvements to major river crossings and trailheads impacted by increased visitation; and

WHEREAS, the Board approved a new 2022 objective "To promote sustainable recreation in partnership with community providers and other jurisdictions to enhance recreational access, support public health and safety, realize economic opportunities, and preserve natural resource assets" at their regular meeting on February 8, 2022, with a specific initiative to "Identify and implement strategies to promote health and safety at river crossings, lakes, trailheads, and other high-use or high-risk areas"; and

WHEREAS, at its 2022 Board Workshop the board identified up to \$850,000 for the "Outdoor Recreation and Visitor Safety Fund" through a combination of American Rescue Plan Act funding and Transient Occupancy Tax funds; and

WHEREAS, these expenditures will be aligned with the ARPA final rule priority of "2.22: Strong Healthy Communities: Neighborhood Features that Promote Health and Safety"; and

WHEREAS, the County released a request for proposals for eligible entities which included nonprofit organizations, for-profit businesses, special purpose districts, and pending availability of general fund moneys, State and Federal agencies, to respond to the negative economic impacts of the COVID-19 pandemic with proposals that will increase resiliency and promote health and safety at highly impacted outdoor recreation destinations; and

WHEREAS, 19 concept proposals were received from 10 organizations, totaling \$1,377,817 in requests; and

WHEREAS, a 5-member evaluation panel (Panel), consisting of two community leaders and three county staff, reviewed and scored concept proposals; and

WHEREAS, 13 proposals from 9 different organizations were invited to submit a full proposal; and

WHEREAS, the County received six final full proposals from five individual eligible entities totaling \$361,965; and

WHEREAS, the same Panel again reviewed and scored applications to provide the County Executive Officer (CEO) with a recommended list of six projects from five eligible awardees; and

WHEREAS, the Panel presented recommendations to the CEO and the CEO identified the six proposals from five different organizations for recommendation to the Board of Supervisors for final approval and award; and

WHEREAS, Grant Award Recipient Agreements were developed on a case-by-case basis and reviewed with the Auditor-Controller to ensure the grantees are in good standing with the County; and

WHEREAS, Grant Award Recipients will enter in the attached "Grant Award Recipient Agreement" with the County, specifying the use the ARPA monies to cover only those eligible costs identified in the RFA and necessary for the COVID-19 public health emergency in accordance with federal guidance, and further affirming the Grant Award Recipient shall be responsible for reimbursement to County of any grant funding provided under this agreement that are determined by federal or state officials to be unauthorized expenditures, and additionally specifying that grant recipients will provide quarterly reports beginning in September 2022; and

WHEREAS, to promote transparency, required quarterly reporting will be posted on the County of Nevada's American Rescue Plan "ARPA" web page; and

WHEREAS, an amendment to the 2022/2023 Recreation budget presented under file ID 22-0786 authorizes \$450,000 in American Rescue Plan Act funding for the Outdoor Visitor Safety Fund; and


WHEREAS, the grant award is contingent upon the adoption of the Fiscal Year 2022/23 County Budget; and

WHEREAS, South Yuba River Citizens League's Golden Quartz Picnic Area Vault Toilets proposal was among the six approved for funding.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that:

- 1. The Grant Award Recipient Agreement awarding \$46,371 in an "Outdoor Visitor Safety Fund Grant" to South Yuba River Citizens League is hereby approved.
- 2. The Chair of the Board of Supervisors is authorized to execute the grant agreement on behalf of the County of Nevada for the "Outdoor Visitor Safety Fund" which is hereby approved and attached hereto.

#### **GRANT AWARD RECIPIENT AGREEMENT**

**THIS AGREEMENT** ("Agreement") is made at Nevada City, California, by and between the County of Nevada, ("County"), and South Yuba River Citizens League (SYRCL) ("Grant Recipient"), who agree as follows:

- 1. <u>Use of Funds</u>: Grant Recipient agrees to use the County of Nevada's American Rescue Plan Act ("ARPA") allocation for "Community & Economic Resiliency" in full compliance with all ARPA Fund expenditure requirements and for the purposes set forth in Exhibit A.
- 2. <u>Grant Fund Allocation</u> County shall allocate ARPA Funds designated specific to the coronavirus relief efforts in the time and in the amount set forth in Exhibit B. The amount of the ARPA Funding shall not exceed Forty-six thousand three hundred and seventy-one dollars (\$46,371).
- 3. <u>Term</u> This Agreement shall be effective upon the date on which the last party hereto has executed this Agreement ("Effective Date"). All grant funds provided by this Agreement shall be expended before December 31, 2024 and reported on per the requirements stated in Exhibit C. **Agreement Termination Date** of: 12/31/2024.
- 4. **Exhibits** All exhibits referred to herein and attached hereto are incorporated herein by this reference.
- 5. <u>Electronic Signatures</u> The parties acknowledge and agree that this Agreement may be executed by electronic signature, which shall be considered as an original signature for all purposes and shall have the same force and effect as an original signature. Without limitation, "electronic signature" shall include faxed or emailed versions of an original signature or electronically scanned and transmitted versions (e.g., via pdf) of an original signature.
- 6. <u>Time for Performance</u> Time is of the essence. Failure of Grant Recipient to expend any allocated funding prior to December 31, 2024 shall constitute a return of unspent funds to the County as of the termination date. Grant Recipient shall devote such time to the Coronavirus relief effort pursuant to this Agreement. Grant Recipients unauthorized expenditure of ARPA Funds shall constitute a material breach of this Agreement, and in addition to any other remedy available at law, shall serve as a basis upon which the County may elect to immediately suspend ARPA Fund payments, or terminate this Agreement, or both without notice.
- 7. Hold Harmless and Indemnification Agreement

  To the fullest extent permitted by law, each party (the "Indemnifying Party") hereby agrees to protect, defend, indemnify, and hold the other party (the "Indemnified Party"), its officers, agents, employees, and volunteers, free and harmless from any and all losses, claims, liens, demands, and causes of action of every kind and character resulting from the Indemnifying Party's negligent act, willful misconduct, or error or omission, including, but not limited to, the amounts of judgments, penalties, interest, court costs, legal fees, and all other expenses incurred by the Indemnified Party arising in favor of any party, including claims, liens, debts, personal injuries, death, or damages to property (including employees or property of the Indemnified Party) and without limitation, all other claims or demands of every character occurring or in any way incident to, in connection with or arising directly or indirectly out

of, the Agreement and the expenditures of the ARPA funding. The Indemnifying Party agrees to investigate, handle, respond to, provide defense for, and defend any such claims, demand, or suit at the sole expense of the Indemnifying Party, using legal counsel approved in writing by Indemnified Party. Indemnifying Party also agrees to bear all other costs and expenses related thereto, even if the claim or claims alleged are groundless, false, or fraudulent. This provision is not intended to create any cause of action in favor of any third party against either party or to enlarge in any way either party's liability but is intended solely to provide for indemnification of the Indemnified party from liability for damages, or injuries to third persons or property, arising from or in connection with Indemnifying Party's performance pursuant to this Agreement. This obligation is independent of, and shall not in any way be limited by, the minimum insurance obligations contained in this Agreement. These Hold Harmless and Indemnification provisions shall survive the termination of this Agreement.

- 8. <u>Drug-Free Workplace</u> Senate Bill 1120, (Chapter 1170, Statutes of 1990), requires recipients of state grants to maintain a "drug-free workplace". Every person or organization awarded a contract for the procurement of any property or services shall certify as required under Government Code sections 8355-8357 that it will provide a drug-free workplace.
- 9. **Political Activities** Grant Recipient shall in no instance expend funds or use resources derived from this Agreement on any political activities.
- 10. <u>Reporting Requirements</u> Grant Recipient will be required to maintain records and provide project information to the County or its Contract Administrator as provided in Exhibit C.
- 11. Conflict of Interest Grant Recipient certifies that no official or employee of the County, nor any business entity in which an official of the County has an interest, has been employed or retained to solicit or aid in the procuring of this Agreement. In addition, Grant Recipient agrees that no such person will be employed in the performance of this Agreement unless first agreed to in writing by County. This includes prior Nevada County employment in accordance with County Personnel Code.
- 12. <u>Entirety of Agreement</u> This Agreement contains the entire agreement of County and Grant Recipient with respect to the subject matter hereof, and no other agreement, statement, or promise made by any party, or to any employee, officer, or agent of any party, which is not contained in this Agreement, shall be binding or valid.
- 13. <u>Alteration</u> No waiver, alteration, modification, or termination of this Agreement shall be valid unless made in writing and signed by all parties, except as expressly provided in Section 19, Termination.
- 14. Governing Law and Venue This Agreement is executed and intended to be performed in the State of California, and the laws of that State shall govern its interpretation and effect. The venue for any legal proceedings regarding this Agreement shall be the County of Nevada, State of California. Each party waives any Federal court removal and/or original jurisdiction rights it may have.
- 15. <u>Compliance with Applicable Laws</u> Grant Recipient shall comply with any and all federal, state, and local laws, codes, ordinances, rules, and regulations which relate to, concern of affect the Services to be provided by this Agreement.
- 16. <a href="Prevailing Wage">Prevailing Wage</a> The services described herein may be considered "public works" as defined by California Labor Code section 1720 et seq. Any funds expended as a result of this award Grant Recipient will be responsible for compliance with all applicable prevailing wage laws, as well as any and all applicable state or federal wage laws, for services under the awarded Agreement.

17. Subrecipient Community Resiliency grantees are not considered subrecipients. Grant Recipients should follow appropriate rules, regulations, and best financial practices with respect to management of federal funds. To the extent applicable Grant Recipient is subject to the Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards, 2 CFR Part 200 et al (commonly referred to as the "OMB Super Circular" or "Uniform Guidance"). A copy of these regulations is available at the link provided herein for the Code of Federal Regulations.

#### **PURPOSE AND USE OF FUNDS**

Grant Recipient agrees to use the County of Nevada's American Rescue Plan Act ("ARPA") allocation for "Community & Economic Resiliency", specifically, "Outdoor Visitor Safety Fund" provided to cover those costs identified in the submitted Application received from this Entity which is attached hereto and incorporated herein as Exhibit A-1. These funds are designated to respond to the negative economic impacts of the COVID-19 pandemic with a project that will increase resiliency and promote health and safety at highly impacted outdoor recreation destinations. Nevada County experienced a significant increase in visitation to outdoor recreation

destinations during the pandemic.

Funds may be allocated flexibly among proposed line items up to 10% of each line item; budget modifications greater than 10% of changed line item must be requested and have written approval by County grant manager.

The Community Benefit Grant awards are consistent with ARPA guidelines "to respond to the public health emergency or its negative economic impacts, including assistance to households, small businesses, and nonprofits, or aid to impacted industries such as tourism, travel, and hospitality." CONFLICTS OF INTEREST. Grant Recipient understands and agrees it must maintain a

Grant Recipient ensures its current and future compliance with Title VI of the Civil Rights Act of 1964, as amended, which prohibits exclusion from participation, denial of the benefits of, or subjection to discrimination under programs and activities receiving federal financial assistance, of any person in the United States on the ground of race, color, or national origin (42 U.S.C. § 2000d et seq.), as implemented by the Department of the Treasury Title VI regulations at 31 CFR Part 22 and other pertinent executive orders such as Executive Order 13166, directives, circulars, policies, memoranda, and/or guidance documents.
    - 2. Grant Recipient acknowledges that Executive Order 13166,

"Improving Access to Services for Persons with Limited English Proficiency," seeks to improve access to federally assisted programs and activities for individuals who, because of national origin, have Limited English Proficiency (LEP). Recipient understands that denying a person access to its programs, services, and activities because of LEP is a form of national origin discrimination prohibited under Title VI of the Civil Rights Act of 1964 and the Department of the Treasury's implementing regulations. Accordingly, Recipient shall initiate reasonable steps, or comply with the Department of the Treasury's directives, to ensure that LEP persons have meaningful access to its programs, services, and activities. Recipient understands and agrees that meaningful access may entail providing language assistance services, including oral interpretation and written translation where necessary, to ensure effective communication in the Recipient's programs, services, and activities.

- 3. Grant Recipient agrees to consider the need for language services for LEP persons when Recipient develops applicable budgets and conducts programs, services, and activities. As a resource, the Department of the Treasury has published its LEP guidance at 70 FR 6067. #### **8.4 TAB A: ENTITY DESCRIPTION** (approximately 500 words):

#### a. Provide a brief description of your entity including mission, goals, and history in Nevada County.

Headquartered in Nevada City, the South Yuba River Citizens League (SYRCL) is the leading advocate for water quality protection, river health, and watershed restoration within the Yuba Watershed. We formed in 1983 to prevent new dams being built on the South Yuba, a goal we reached in 1999. Nearly 40 years later, we are widely recognized as one of the most effective watershed groups in the United States.

**SYRCL's MISSION is** to unite the community to protect and restore the Yuba River watershed. Our awarding-winning watershed science program safeguards water quality and restores imperiled headwater meadows and riverbanks impacted by hydraulic mining. Our robust "River People program" mobilizes thousands of volunteers to protect our public lands and advocate for clean water and forest health. Our world-class environmental film festival – the Wild & Scenic Film Festival – reaches more than 100,000 audience members annually around the world, inspiring them to take action for a sustainable future.

# b. Provide the name(s) of the principal(s) responsible for the entities' organizational operations. Be sure to include their qualifications.

Melinda Booth Executive Director, South Yuba River Citizens League, will administer this grant and oversee the work to ensure grant deliverables are met. Ms. Booth has served as SYRCL's executive director since 2017 and has worked for the organization since 2011. Under her tenure, the organization has grown to have a \$5 million annual operating budget that includes landscape-level conservation work in the Lower Yuba River, the Yuba Headwaters, and the Yuba's Forests.

#### c. Describe the community served by your entity.

SYRCL strives to serve the Yuba watershed, which encompasses portions of Nevada, Yuba, Sierra and Placer counties. The preponderance of our work—restoration, forest health, education, community engagement—takes place in Nevada, Sierra, and Yuba counties.

### a. Describe the economic harm your organization experienced because of the pandemic as it relates to the ARPA guidelines (see 6.0).

Due to COVID-19, SYRCL cancelled fundraising events that supported education and public safety outreach in 2020, 2021, and 2022. Major funders withdrew education grants and national-level sponsors cancelled pledges for the Wild & Scenic Film Festival (WSFF). Fee-for-service revenue dropped, as dozens of organizations who franchise the WSFF cancelled contracts. Ticket sales dropped too. We lost hundreds of volunteer hours for critical tasks that staff were then required to perform. SYRCL had to adapt to the social distancing and stay-athome advisories. This required investing in the following: laptops for telework; an online platform for the WSFF; staff time to develop safety protocols, monitor water quality, post safety signage at the river, and produce content for e-learning; vehicle expenses to ensure social distancing among field staff.

For our fiscal year 2021-2022, we continue seeing reduced income due to COVID-19 from special events, ticket sales, and fee-for-service revenue, which impacts our ability to fund education, our college scholarship, outreach, volunteer, water quality, and fire safety programs.

#### b. Described the impact of COVID-19 on your industry.

SYRCL's industry or "line of work" is protecting and restoring the Yuba River watershed which includes dealing with visitor impacts and safety issues surrounding the watershed. We are taking the lead in requesting resources for a much-needed COVID response for improved infrastructure along the Yuba that will aid visitor health and safety.

Public land managers estimate that the Yuba River visitation has increased by 40% as a result of COVID-19. This situation is over-taxing safety personnel from county, state, and federal agencies, like the USFS staff at the Tahoe National Forest. Local infrastructure is impacted, too: roads, parking, trails, waterways, bridges, etc. Data shows that most visitors are from out of the region and are often first-time visitors. This surge has highlighted the need to address the lack of infrastructure services, which exacerbates the negative social, environmental, safety, and community impacts from COVID-driven visitation. Additionally, it is anticipated visitation will continue to increase now that more people have experienced the magic and beauty of the Yuba River.

Seeing more human waste, pet waste and litter, especially at remotes site, community members are distressed about this public health and safety situation and are coming to SYRCL. We are a focal point for this public outcry that something needs to be done.

#### c. Described impact of COVID-19 related to your proposed project site(s).

Golden Quartz Picnic Area, part of the Tahoe National Forest, is located along the South Yuba River approximately 5 miles upstream of the Town of Washington (23717 Maybert Rd, Nevada City, CA 95959). Per USFS staff, visitation has grown nearly four-fold, especially during the summer. The one existing vault toilet needs replacing: it is old and not wheelchair accessible. In addition, human waste and litter problems have increased. This is especially problematic because of its proximity to the river; COVID-19 virus is detected in human feces, as well as other diseases that endanger public health. A new double vault toilet for the developed parking area has been identified by TNF staff has a high priority health and safety need.

#### 8.6 TAB C: PROJECT DESCRIPTION (approximately 500-1500 words):

a. Describe your project in detail including where it is located, and how it will promote community health, safety, and economy, protect the environment, and enhance resilience.

#### **Double Vault Toilet at Golden Quartz Picnic Area, TNF**

The USFS has identified the Golden Quartz Day Picnic Area as a high priority site for the installation of new public restrooms. This beautiful and ecologically sensitive site is extremely vulnerable to human impacts, including dog and human waste. Replacing the existing single restroom with a new double vault toilet will prevent leakage, increase capacity, and make services wheelchair accessible. Ultimately it will help with public health sanitation, improve visitor experience, and reduce the ongoing problem of human waste impacts on the watershed.

This project proposes to work with the USFS to install a double vault toilet at the developed parking area. USFS will dedicate staff time to remove the existing single restroom, which is in disrepair, conduct the site preparation, oversee the installation and delivery, and perform ongoing long-term maintenance and repair.

SYRCL will work with the USFS to order the appropriate double vault toilet that complies with USFS standards and coordinate with the vendor to schedule delivery as well as manage the overall project timeline and progress.

USFS and SYRCL carried out a similar vault toilet installation at Langs Crossing, near the Yuba River within the Tahoe National Forest, which shows this project can be completed successfully with a similar budget and timeline (see below). There was no National Environmental Protection Act permitting requirement at the Langs project site. It is anticipated no permits will be required for Golden Quartz vault toilet since it is replacing existing facilities.

c. Describe how <u>this proposal</u> directly responds to the negative impacts of the COVID-19 (described in 8.4(a) above) pandemic consistent with ARPA guidelines (include relevant citations from the Interim Final Rule and/or the FAQs as needed).

This proposal to install a double vault toilet responds to the COVID-19-driven surge in outdoor recreation along the Yuba River and the subsequent call for improved amenities and infrastructure. Specifically, the objective is to address the impact of human waste at a sensitive site.

Per the FAQs section 1.8, SYRCL, as a nonprofit organization, is eligible to receive ARPA funding from Nevada County, especially as this proposal is seeking assistance to implement COVID-19 prevention (through the safe containment of human waste) and mitigation measures (FAQ 2.5, 2<sup>nd</sup> bullet).

#### 8.7 TAB D: COMMUNITY BENEFIT (approximately 250-500 words):

a. Describe how this project/program will promote equitable access to recreation, enhance public health and safety, promote economic development, preserve environmental assets, and promote resilience with impactful, measurable outcomes.

Human waste plagues popular recreational sites along the Yuba River, especially along the south fork's Wild & Scenic stretch. Further, this situation cannot be remedied easily through site improvements at remotes areas due to road conditions, access, and permitting issues (on State land). However, SYRCL and USFS have been able to install a public restroom at Langs Crossing (South Yuba River, Tahoe National Forest) within a 9–12-month project timeline. We propose to do it again at Golden Quartz Picnic Area, a similar USFS site.

This new double vault toilet will generally improve visitor services (and health & safety) and reduce human impacts on the Yuba River, one our region's most precious environmental assets. It will help the community and land managers to provide wheelchair accessible services and accommodate visitation growth, which is an economic & public safety benefit.

8.8 TAB E: LEVERAGING PARTNERSHIPS AND RESOURCES (approximately 250-500 words): a. Describe how your entity will leverage additional partnerships, funding and other resources as part of this proposal.

This project at the Golden Quartz site within the Tahoe National Forest will rely on the collaboration of SYRCL and the US Forest Service (USFS).

USFS is contributing staff time to oversee the environmental compliance process, secure a categorical exemption for NEPA (if required), conduct the site preparation and removal of old restroom, oversee the installation and delivery, and perform ongoing maintenance and repair.

SYRCL has donated staff time to developing the project concept. It will also contribute matching dollars to cover its overhead costs. It will also dedicate volunteer time to assess the site after the vault toilet is installed.

SYRCL will serve as the lead entity for this project, which will include managing the overall contract, paying vendors, procuring the related infrastructure from Boom Concrete, Inc., scheduling delivery, deploying field staff and volunteers after project completion for site assessment, and coordinating with the USFS. Additionally, SYRCL will handle communications and social media to build awareness and public support for this project.

The USFS will seek internal agency approvals and manage the overall site preparation, old restroom removal, and new restroom construction. It also will be responsible for ongoing maintenance and repair of the toilets.

As a primary outcome, the new double vault toilet will generally improve accessibility and visitor services (and health & safety) and reduce human impacts on the Yuba River. It will be a marketable eco-tourism benefit and help the community and land managers accommodate visitation growth, an economic & public safety benefit.

We will measure the success of this project by monitoring site conditions and surveying USFS staff observations on use and reduction of human waste.

We will report on the progress and benefits of this project through SYRCL's annual impact report, website, and social media. Of course, we will comply with all grant reporting requirements outlined in the final grant contract.
