OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION AUTHORIZING THE CAPITAL ASSET PURCHASE OF A LIBRARY NETWORK FIREWALL SOLUTION FOR \$18,530.60 WITH SUBSCRIPTION AND SUPPORT IN THE AMOUNT OF \$40,514.20 FOR A TOTAL COST OF \$59,044.80 AND AMENDING THE FISCAL YEAR 2022-23 INFORMATION SYSTEMS AND LIBRARY BUDGETS IN THE AMOUNT OF \$59,044.80 (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, Information and General Systems supports and maintains the network infrastructure for the County Library system; and

WHEREAS, County Library Internet network connectivity has become increasingly important to our community; and

WHEREAS, internet access for visitors to County Libraries enhances their visit and accessibility to services. The current system has been in service for many years and has reached end of life, necessitating replacement; and

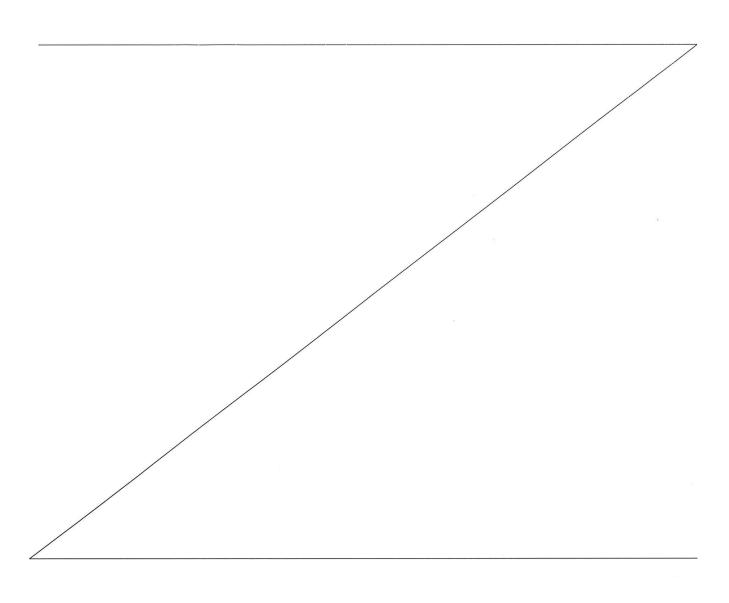
WHEREAS, County Purchasing has solicited competitive quotations and selected the best value proposal; and

WHEREAS, products from Palo Alto Networks have proven to provide reliable and secure service to the County of Nevada for many years.

NOW, THEREFORE, BE IT RESOLVED the Board of Supervisors of the County of Nevada, State of California, hereby:

- 1. Approves the capital asset purchase of the Palo Alto Firewall and installation in the amount of \$18,530.60 and the purchase of the subscription and support in the amount of \$40,514.20 for a total purchase of \$59,044.80
- 2. Authorizes the Purchasing Agent to execute all quotes and forms, encumber the funds and process the procurements for the Palo Alto Firewall, subscriptions and installation.
- 3. Directs the Auditor-Controller to release Library Fund balance in the amount of \$59,044.80 and amend the Fiscal Year 2022/23 Information Systems and Library department budgets as follows:
