RESOLUTION ACCEPTING AWARD FOR FISCAL YEAR 2021-22 LOW CARBON TRANSIT OPERATIONS PROGRAM (LCTOP) PUC 99313 AND 99314 FUNDING IN THE AMOUNT OF \$132,811 FOR THE DESIGN, PURCHASE, INSTALLATION AND OPERATION OF A CONTACTLESS FARE PAYMENT SYSTEM

WHEREAS, the Board of Supervisors on April 26, 2022, approved the submittal of an application for total LCTOP funds of \$132,811 to fund the Design, Purchase, Installation and Operation of a Contactless Fare Payment system for use on all Nevada County Connects fixed route buses (Contactless Fare System); and

WHEREAS, the application was submitted by the Transit Services Division, and approval of the project application and funding award has been received from the Department of Transportation/Division of Rail and Mass Transportation; and

WHEREAS, the Transit Services Division has been awarded \$132,811 in capital funds for the Contactless Fare System project.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors accepts the award for LCTOP funding in the amount of \$132,811 to be deposited into Transit Services Fund 4281-91003-707-1000/445090.
