SUBJECT: Resolution authorizing environmental clearance for the 2023 Road Rehabilitation Project – District II & IV.

RECOMMENDATION: Approve the attached resolution.

FUNDING: The 2023 Road Rehabilitation Project will be part of the Capital Improvement Plan (CIP) for Fiscal Years 2022-23 and 2023-24. It will be funded by SB1 Road Maintenance and Rehabilitation Act (RMRA) funds in Road Engineering, and fund balance from CSA 38 Zone 2 and CSA 1 Zone 1. A budget amendment may be necessary in any of the three budget units if the construction contract is awarded in Fiscal Year 2022-23. There is no impact to the General Fund.

BACKGROUND: The Department of Public Works is going to perform required road maintenance and preservation activities involving dig out and repair, crack sealing, asphalt overlay, and marker and striping replacement on approximately 4.8 miles of County maintained roads. The roads involved in the project include Dog Bar Road from Alta Sierra Drive to Mt Olive Road, Dog Bar Road from Morning Sun Lane to Magnolia Road, Carrie Drive, Cougar Court, Bobcat Court, and Gold Country Drive. A map of the streets is shown in Exhibit A.

The Public Works Department has reviewed the project for compliance with the California Environmental Quality Act Statutes and Guidelines and has identified it as categorically exempt from the provisions of CEQA per Section 15301(c).

Under Section 15301(c) of the CEQA Guidelines, Class 1 projects consisting of the repair and maintenance of existing streets are categorically exempt from the provisions of CEQA.

A Notice of Exemption has been prepared for the project, and upon approval by the Nevada County Board of Supervisors, will be filed with the Nevada County Clerk-Recorder's Office.
