

# PUBLIC NOTICE OF COMMITTEE VACANCIES

The Nevada County Board of Supervisors is seeking interested persons to serve on the following:

# \*ADULT AND FAMILY SERVICES COMMISSION: (3 vacancies, 6 positions)

One Public Sector vacancies for unexpired two-year term ending April 30, 2024; one Low-Income Sector vacancy for unexpired two-year term ending April 30, 2024; and one Private Sector vacancy, for two-year term becoming available May 1, 2024 and ending April 30, 2025. Additionally, there are three Low-Income Sector positions, two Public Sector positions and one Private Sector position becoming available May 1, 2024 for two-year terms ending April 30, 2025. This Commission shall operate under the Nevada County Board of Supervisors as the primary advisory body relative to health and human service's needs and performs the responsibilities of the Board of Directors as described under Title 42 USC Chapter 106 § 9910 - Tripartite Boards. Private Sector members shall represent labor, business, or other private business, industry, labor, religious, human services, education, or other major groups and interests in the community. # \*AGRICULTURAL ADVISORY COMMISSION: (2 positions)

One Forest & Related Industry Representative position becoming available March 2, 2023, for a 4-year term ending March 31, 2027. One Agricultural Interests Representative position becoming available April 1, 2023, for a 4-year term ending March 31, 2027. The Commission shall advise the Board of Supervisors on matters concerning the agricultural resources of the County; develop a framework for cooperation among agencies and institutions, interest groups, individuals, public and private property owner, and all others for wise conservation and management of resources to benefit the County's agricultural assets; and maintain an active Agricultural Commission to advise the County on agricultural-related matters. # \*ASSESSMENT APPEALS BOARD: (1 vacancy)

One vacancy for alternate member to fill unexpired one-year term ending September 30, 2023. Specific qualifications are required per Section 1624 of the Revenue and Taxation Code. The function of the Appeals Board is to determine the full value of property or to determine other matters of property tax assessment over which the Appeals Board has jurisdiction. The Board acts in a quasi-judicial capacity and renders its decision only on the basis of proper evidence presented at the hearing. The functions of the Board are outlined in Section 1620 et seq. of the Revenue and Taxation Code. Compensated per Administrative Code Chapter II, Article 13.11. #### **BOARD OF TRUSTEES OF THE LAW LIBRARY: (2 positions)**

Two Board of Supervisors appointed representatives for one-year terms ending on January 31, 2024. \*BUILDING AND ACCESSIBILITY STANDARDS BOARD OF APPEALS: (2 vacancies)
One member-at-large vacancy to be filled by a person with a disability who is qualified by experience and training to pass on matters pertaining to building construction, building service equipment and grading, for an unexpired four-year term ending July 1, 2023. One vacancy for member appointed by District I Supervisor, to be selected from the County at large, for term unexpired term ending December 31, 2023. This Board rules on appeals of discretionary orders, decisions or determinations made by the Building Official relative to the application and interpretation of the provisions of the technical codes. # <u>CITIZENS' OVERSIGHT COMMITTEE OF THE NEVADA COUNTY LIBRARY:</u> (2 vacancies, 2 positions)

Two member vacancies to fill unexpired four-year terms ending March 31, 2025. To ensure that the Eastern and Western Nevada County libraries receive equitable amounts of the Nevada County Library Fund and operate in accordance with the Nevada County Library Strategic Plan, residents from Eastern County are encouraged to apply. Two member positions becoming available April 1, 2023 for four-year terms ending March 31, 2027. This Committee reviews, advises, and monitors the library's revenues, expenditures, and services. The goals of this committee are 1) to ensure that the County of Nevada receives all library tax monies collected by the Board of Equalization and that those monies are placed in the Nevada County Library Fund; 2) to ensure that the county of Nevada annually transfers its maintenance and effort funds, under the provisions of state laws, to the Nevada County Library Fund; 3) to ensure that the Eastern and Western Nevada County libraries are receiving equitable amounts of the Nevada County Library Fund and operate in accordance with the Nevada County Library Strategic Plan; 4) to review and advise the County Librarian on the Strategic Plan and the annual County Library Budget; and 5) to facilitate the free flow of regular communication between the Committee and all interested library patrons and organizations.
