**SUBJECT:** Resolution authorizing the Chair of the Board to sign the Invitation to bid and the Purchasing Agent to solicit bids for the 2023 Road Rehabilitation Project, County Project Number 450011, Districts I, II, and IV.

**RECOMMENDATION:** Adopt the attached Resolution authorizing the Chair of the Board to sign the Invitation to Bid, and authorizing the Purchasing Agent to solicit bids for the 2023 Road Rehabilitation Project.

**FUNDING:** The 2023 Road Rehab Project will be paid for with Road Maintenance and Rehabilitation Act (RMRA) funds, and funds from County Service Area (CSA) 38 Zone 2 and CSA 1A Zone 1, there is no impact to the General Fund. The project is included in the FY 2022/23 and FY 2023/24 Capital Improvement Program for Road Engineering and the CSAs.

**BACKGROUND:** On January 10, 2023, the Nevada County Board of Supervisors approved Resolution No.23-017 an environmental clearance for pavement rehabilitation along multiple county-maintained roads and two CSA locations.

The Department of Public Works is proposing to rehabilitate approximately 4.8 miles of roadway using a combination of asphalt repairs, and resurfacing as shown on Attachment A. The Director of Public Works may make adjustments to the roadways listed as necessary. This project also includes shoulder widening and drainage modification to help relieve constricted portions of Dog Bar Road.

The project specifications and cost estimate for this project have been completed. The Engineer's estimate is \$1,667,000.00, plus a 10% contingency of \$166,700.00 for a total not to exceed contract of \$1,833,700.00.

The bid opening date will be set by the Director of Public Works, with construction schedule to begin in the summer of 2023.
