OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING THE ACCEPTANCE OF FUNDS FROM THE DEPARTMENT OF HEALTH CARE SERVICES UNDER THE CAPACITY AND INFRASTRUCTURE, TRANSITION, EXPANSION AND DEVELOPMENT (CITED) PROGRAM, WHICH IS PART OF THE CALIFORNIA PROVIDING ACCESS AND TRANSFORMING HEALTH (PATH) INITIATIVE FOR THE PURPOSE OF SUPPORTING THE ENHANCED CARE MANAGEMENT TEAM IN THE MAXIMUM AMOUNT OF \$336,533 FOR THE TERM OF JULY 1, 2022 THROUGH DECEMBER 31, 2023 AND DIRECTS THE AUDITOR-CONTROLLER TO AMEND THE BEHAVIORAL HEALTH BUDGET FOR FISCAL YEAR 2022/23 (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, on January 31, 2023, the California Department of Health Care Services under the CITED Program, which is part of the California Providing Access and Transforming Health (PATH) Initiative allocated to the Nevada County Behavioral Health Department \$336,533 to support implementation of their Enhanced Care Management Team; and

WHEREAS, these funds will assist the Enhanced Care Management team in more effectively serving people experiencing homelessness who also have mental health or substance use disorder needs; and

WHEREAS, the Nevada County Behavioral Health Department will utilize these funds to supplement staffing costs, enhance training and capacity, purchase a vehicle and develop office space for these services.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the County is hereby authorized to accept the California Department of Health Care Services under the Capacity and Infrastructure, Transition, Expansion and Development (CITED) Program, which is part of the California Providing Access and Transforming Health (PATH) Initiative funding in the maximum amount of \$336,533 for the term of July 1, 2022 through December 31, 2023, be and hereby is approved in substantially the form attached hereto, and that the Board of Supervisors be and is hereby authorizes the Director of Behavioral Health, or her designee, to sign this Acknowledgement of Grant Terms and Conditions and any necessary documents in connection with this award and all amendments thereto, on behalf of the County of Nevada and authorizes and directs the Auditor-Controller amend Behavioral Health's budget as follows:
