## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

## **RESOLUTION AUTHORIZING THE CAPITAL ASSET** PURCHASE OF AN ICE AND WATER DISPENSER IN THE AMOUNT OF \$5,227.30 FOR THE ERIC ROOD ADMINISTRATIVE **CENTER CAFÉ AND DIRECTING THE AUDITOR-CONTROLLER** TO AMEND THE FISCAL YEAR 2022/23 FACILITIES BUDGET (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, the café located in the Eric Rood Administrative Center is currently between vendors and is undergoing a refresh; and

WHEREAS, this refresh of the space includes painting, resurfacing the countertops, and replacing equipment as needed; and

WHEREAS, the purchasing department assisted facilities in locating the best price for the ice and water dispenser that is needed to be replaced in the café space.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Chair of the Board of Supervisors approves the capital asset purchase of a Scotsman Model Ice and Water Dispenser in the amount of \$5,227.30 from Hubert Co., that the Purchasing Agent is authorized to sign all documents related to the purchase, and directs the Auditor Controllers Office to amend the Fiscal Year 2022/23 Facilities Department budget as follows:
