## RESOLUTION AUTHORIZING THE PROCESS TO SELECT A TREASURER-TAX COLLECTOR TO FILL THE VACANCY DUE TO THE RETIREMENT OF THE CURRENT TREASURER-TAX COLLECTOR TINA VERNON

WHEREAS, Treasurer-Tax Collector Tina Vernon has announced her retirement effective April 29, 2023; and

WHEREAS, the current term of Treasurer-Tax Collector ends January 4, 2027, at noon; and

WHEREAS, pursuant to Government Code section 24105, if no appointment is made by April 29, 2023, Michelle Bodley, as the Assistant Treasurer-Tax Collector, would fulfill the role of Interim Assistant Treasurer-Tax Collector until an appointment is made by the Board of Supervisors; and

WHEREAS, pursuant to California Government Code section 25304 the Board of Supervisors shall fill by appointment all elective County officer vacancies that arise before the end of the current term, 2023-2027; and

WHEREAS, the Board of Supervisors desires to fill the office of the Treasurer-Tax Collector with a qualified appointee as required by California Government Code section 27000.7 and Nevada County Code section A-II 37.2; and

WHEREAS, two options are proposed for the Board of Supervisors to consider to fill the vacancy; and

WHEREAS, the two options are to make a direct appointment or to run a recruitment to fill the position, using an ad hoc selection committee appointed by the Chair of the Board.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors hereby resolves to fill the position by the direct appointment of Assistant Treasurer-Tax Collector Michelle Bodley, beginning on April 29, 2023, to fill the Treasurer-Tax Collector position through the term ending January 4, 2027, at noon.

Dear Honorable Supervisors:

I am writing to you to express my wholehearted support for the appointment of Michelle Bodley to the position on Treasurer-Tax Collector upon the resignation of Tina Vernon. I had the pleasure of working with Michelle Bodley while I served as the Health and Human Services Agency Director overseeing the Departments of Social Services, Public Health, Social Services, Child Support and Housing Services from 2005 to 2013. Michelle and I worked together during a time of significant fiscal and programmatic responsibility changes when 2011 Realignment was enacted. Michelle served as the Senior Accountant Auditor within the Auditor's Office and helped to develop the accounting fiscal structure that still exists today among all realigned departments.

Michelle promoted from the Auditor's Office to become the Administrative Services Officer for the Department of Social Services in 2012 and was responsible for the oversight of a \$46 million budget and management of 10 budget units including CalWORKS, Medi-Cal, Child Protective Services, Adult Protective Services, Veteran's Services, Child Support, and Collections. I am writing to you regarding your upcoming Treasurer-Tax Collector appointment decision upon the resignation of Tina Vernon. My sincere appreciation goes to Tina for her outstanding service as the elected Treasurer Tax Collector. Her dedication and leadership have provided our County with a stable resource on which the community can depend for 12 years.

Please accept my recommendation in favor of the appointment of Michelle Bodley. I had the pleasure of working with Michelle while I served as a Management Analyst in the County Executive Office and as her direct supervisor as the Chief Fiscal Administrative Officer for the Health and Human Services Agency (HHSA) during the years of 2013 - 2017.

Michelle is self-directed, follow-through oriented, and often needed to work independently to manage large projects with complex deliverables. She effectively reallocated resources where necessary to cover critical staffing outages and to complete significant annual events such as the budget and contract renewal seasons. A key to Michelle's success within HHSA was her ability to complete work assignments in a fastpaced, highly demanding environment. She blocked out time on her schedule and spent focused, uninterrupted time planning and meeting deadlines.
