SUBJECT: Resolution to award the contract for the 2023 Road Rehabilitation Project to Baldwin Contracting Company, Inc. dba Knife River Construction for a total amount of \$1,401,348.56 under County contract number 450011 – Districts 1, 2 and 4

RECOMMENDATION: Approve the attached resolution.

FUNDING: This project will be funded with Road Maintenance and Rehabilitation Act (RMRA) funds, and funds from County Service Area (CSA) 38 Zone 2 and CSA 1 Zone 1. There is no impact to the General Fund.

BACKGROUND: On February 28, 2023, the Nevada County Board of Supervisors approved Resolution 23-082 to authorize the Purchasing Agent to solicit bids for the 2023 Road Rehabilitation Project. These bids were opened on April 13, 2023, and are listed below:

The low bidder for this contract is based on the bid excluding the Add/Alt item.

It is recommended that the contract be awarded to the low bidder, Baldwin Contracting Company, Inc. dba Knife River Construction at the bid price of \$1,273,953.24, which includes the base bid and the additive alternate plus a 10% contingency of \$127,395.32 for a total of \$1,401,348.56. Work is expected to begin in June 2023.
