Chief Policy Officer Wong-Hernandez requested the Board adopt the propose Resolution, providing support for CSAC's strategy. Ryan Gruver, Health and Human Services Agency Director, reported on the County's Homelessness Plan, which incorporates the State's Action Plan. Director Gruver noted that CSAC's AT HOME Plan addressed many of the issues that Nevada County is experiencing, and aligns with the County's direction.

Chief Policy Officer Wong-Hernandez responded to Board questioning and discussion ensued.

Chair Scofield provided an opportunity for public comment, and comments were received.

Supervisor Hall thanked her colleagues for their input; she believed that the County is ahead of other rural counties.

ACTION TAKEN: Supervisor Hoek reported on the proposed letter of opposition to Assembly Bill (AB) 338, suggesting that requiring prevailing wage could negatively impact work being done on wildfire prevention.

Jeffrey Thorsby, Senior Management Analyst, supported by Trisha Tillotson, Community Development Agency Director, Craig Griesbach, Office of emergency Services Director, and Desiree Belding, Deputy Purchasing Agent, reported on the bill. Management Analyst Thorsby noted that the Rural County Representatives of California (RCRC) is opposed to the bill, which would expand the definition of "public works" for the purpose of providing prevailing wages, to also include fuel reduction work done under contract and paid for, or in part by, public funds performed as part of a fire mitigation project. Management Analyst Thorsby noted that currently the majority of Nevada County's contracts for wildfire management already pay their workers prevailing wage; it is likely that the legislation would increase the costs by 30%. AB 338 could impact and eliminate local jobs rather than create them by placing small, local contractors at a competitive disadvantage for fuels reduction work in Nevada County.

Staff responded to Board questioning and discussion ensued.

Supervisor Hall shared concerns about the importance of paying workers a living wage; when individuals are not paid a living wage, it ends up increasing the need for County services, which are provided at the taxpayer's expense.

MOTION: Motion made by Supervisor Hoek, and seconded by Supervisor Swarthout, to authorize the Chair of the Board to sign the Letter of Opposition. On a roll call vote, the motion passed as follows: Ayes: Supervisors Scofield, Swarthout, and Hoek; Noes: Supervisors Hall and Bullock.
