RESOLUTION APPROVING AMENDMENT NO. 1 TO PERSONAL SERVICES CONTRACT WITH PLACEWORKS, INC. RELATED TO THE PREPARATION OF THE SOUTH COUNTY AREA PLAN EXTENDING THE CONTRACT TERM TO JULY 31, 2023 AND AUTHORIZING THE CHAIR OF THE BOARD TO EXECUTE THE AMENDMENT

WHEREAS, On July 14, 2021, by Resolution 21-297, the parties executed a Personal Services Contract with PlaceWorks, Inc., for services related to the preparation of the South County Area Plan ("Greater Higgins Area Plan"); and

WHEREAS, the project is completed, and an extension of the Contract term is necessary to issue payment for final invoices related to services provided under this Contract; and
