



# **RESOLUTION No. 23-023**

## **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

### **RESOLUTION APPROVING AMENDMENT NO. 1 TO THE MEMORANDUM OF UNDERSTANDING BETWEEN THE COUNTY OF NEVADA AND THE NEVADA COUNTY SHERIFF'S SEARCH AND RESCUE TO UPGRADE THEIR COMMUNICATION DEVICES AND SYSTEMS EXTENDING THE TERMINATION DATE TO DECEMBER 31, 2023, AND AUTHORIZING THE CHAIR OF THE BOARD TO EXECUTE THE AMENDMENT**

WHEREAS, on September 14, 2021, through Resolution 21-410 the Board of Supervisors approved the Memorandum of Understanding ("MOU") between the County Office of Emergency Services and Nevada County Sheriff's Search and Rescue for a communication upgrade project which includes handheld radios, mobile vehicle radios and installation, and expansion of ROIP repeater/interoperability system at 20 separate locations; and

WHEREAS, the Nevada County Sheriff's Search and Rescue has made significant progress in the project. They have completed the purchase of 100 new handheld radios to replace the current outdated equipment and 60 additional radios to be utilized by mutual-aid personnel during an emergency, 5 "Pelican" style ruggedized cases for storage, and replaced and upgrade fifteen vehicle mounted mobile radios; and

WHEREAS, 13 ROIP repeaters that have been installed with 7 more needing installation. Both parties wish to amend the MOU to allow for additional time to complete the purchase and installation needed for the 7 remaining ROIP repeater sites throughout the County.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Nevada County, State of California authorizes the Office of Emergency Services to approve Amendment No. 1 to the MOU between the County of Nevada and the Nevada County Sheriff's Search and Rescue extending the termination date to December 31, 2023, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment.

**WHEREAS**, the parties desire to amend their agreement to allow or provide for additional time to install the radio over internet protocol equipment; and


**NOW, THEREFORE**, the parties hereto agree as follows:
