

# RESOLUTION No. 23 - 390

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING EXECUTION OF AN AMENDMENT TO THE REVENUE AGREEMENT WITH THE TULARE SUPERINTENDENT OF SCHOOLS, A POLITICAL SUBDIVISION OF THE STATE OF CALIFORNIA, DOING BUSINESS AS THE CALIFORNIA FRIDAY NIGHT LIVE PARTNERSHIP (CFNLP) PERTAINING TO THE FRIDAY NIGHT LIVE/CLUB LIVE PROGRAM IN NEVADA COUNTY TO INCREASE THE MAXIMUM CONTRACT PRICE FROM \$9,000 TO \$18,000 (AN INCREASE OF \$9,000) AND REVISE EXHIBIT "B", SCHEDULE OF CHARGES AND PAYMENTS TO REFLECT THE INCREASE IN THE MAXIMUM CONTRACT PRICE AND A TERM EXTENSION TO JUNE 30, 2024 (RES 22-499)

WHEREAS, on September 27, 2022, per Resolution 22-499, the Nevada County Board of Supervisors approved execution of an Agency Agreement with the Tulare County Superintendent of Schools, through its program the California Friday Night Live Partnership (CFNLP), to support the implementation of Friday Night Live and Club Live programs in Nevada County; and

WHEREAS, Nevada County has had CFNLP programs, including Friday Night Live, Club Live and Friday Night Live mentoring, for nearly 30 years, and these programs increase protective factors for youth as part of Public Health's alcohol and other drug prevention work in Nevada County; and

WHEREAS, the parties desire to amend their Agreement to increase the contract price from \$9,000 to \$18,000 (an increase of \$9,000), extend the Agreement by one year, and amend Exhibit "B" Schedule of Charges and Payments to reflect the increase in the maximum contract price and a term extension to June 30, 2024.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Amendment by and between the County and the Tulare County Superintendent of Schools, a political subdivision of the State of California, d/b/a California Friday Night Live Partnership pertaining to the Friday Night Live (FNL) program for the term of July 1, 2022 through June 30, 2024, in the maximum amount of \$18,000, be and hereby is substantially approved in the same form attached hereto, and that the Chair of the Board is hereby authorized to execute the Amendment on behalf of the County of Nevada.

Re: CFNLP Substance Abuse Block Grant (SABG) Amendment – Change to Scope of Services

The CFNLP is entering Year 2 of serving as the funding intermediary for Friday Night Live (FNL) Substance Abuse Block Grant (SABG) between the Department of Health Care Services (DHCS) and the counties that implement the FNL program.

CFNLP prepared amendments in order to cost-extend each county's contract or agency agreement. These amendments included an updated Exhibit A, Scope of Services. The amendments were fully routed and signed by Mr. Hire in May 2023.

We recently received additional feedback from the funder, DHCS, regarding language that they want to add to the Scope of Services. Specifically, they would like it to be explicit that counties have the right to use the FNL brand and materials by having the SABG contract with CFNLP/TCOE. As such, we are proposing the following addition to the "Responsibilities of Superintendent" section of the Scope of Services:

The CFNLP/Superintendent will give the contractor the sole right to use FNL branding and materials in their respective county.

Please see attached an example of the Scope of Services with this proposed addition highlighted.

Instead of re-routing 41 amendment packets, we respectfully ask that you agree to this material addition to the Scope of Services by signing below. Please let me know if you have any questions or concerns.

#### TULARE COUNTY SUPERINTENDENT OF SCHOOLS AND NEVADA COUNTY PUBLIC HEALTH

THIS AMENDMENT TO AGREEMENT is entered into as of July 1, 2023, between the TULARE COUNTY SUPERINTENDENT OF SCHOOLS, referred to as **SUPERINTENDENT**, and **NEVADA COUNTY PUBLIC HEALTH**, referred to as **AGENCY** with reference to the following:

- A. The parties entered into an Agreement on October 17, 2022, to implement Friday Night Live (FNL) programming in Nevada County as described therein, herein referred to as "Agreement;"
- B. The parties now desire to:
  - a. Extend the Agreement by one year;
  - b. Increase the amount of the Agreement;
  - c. Replace Exhibit A with amended Exhibit A, Scope of Work 2022-2024; and
  - d. Add Exhibit B.

#### **ACCORDINGLY, IT IS AGREED:**

1. Paragraph 1 of the Agreement is hereby amended to read as follows:

**1. TERM:** This Agreement shall become effective July 1, 2022 and shall expire on June 30, 2024.

2. Paragraph 3 of the Agreement is hereby amended to read as follows:

**3. COST OF SERVICES:** SUPERINTENDENT shall pay AGENCY the actual costs of such services to the extent they are allowable not to exceed the sum of \$18,000.00.

- 3. Exhibit A shall be replaced with amended Exhibit A, Scope of Work 2022-2024.
- 4. Exhibit B is now included in the Agreement.
- 5. Except for the amended paragraphs and exhibits of said Agreement, all other terms and conditions of said Agreement shall remain in full force and effect.

THE PARTIES, having read and considered the above provisions, indicate their agreement by their authorized signatures below.

# SCOPE OF SERVICES, 2022 - 2024

### Amended July 1, 2023

## **1. RESPONSIBILITIES OF CONTRACTOR:**

- Implement Friday Night Live (FNL) program(s) (Friday Night Live [FNL], Club Live [CL], Friday Night Live Kids [FNLK], and/or Friday Night Live Mentoring [FNLM]) by supporting existing chapters and developing new chapters, utilizing FNL Standards of Practice (Exhibit B).
- Demonstrate efforts to become a Member in Good Standing (MIGS). MIGS is a peer-driven process led by the California Friday Night Live Partnership (CFNLP) and the California Friday Night Live Collaborative Leadership Team (CFNLC LT). MIGS areas include:
  - A foundation of youth development, as realized through the implementation of the FNL Standards of Practice, in each program;
  - Implementation of an alcohol, tobacco, or other drug (ATOD) prevention-related project;
  - Program branding; and
  - Administrative requirements as communicated by the CFNLP and CFNLC LT.
- Report chapter activities through an online portal on a quarterly basis.

## 2. RESPONSIBILITIES OF SUPERINTENDENT:

- The California Friday Night Live Partnership (CFNLP)/Superintendent will provide technical assistance (TA) to support the successful implementation of all contractor responsibilities.
- The CFNLP/Superintendent will give the contractor the sole right to use FNL branding and materials in their respective county.
