OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING EXECUTION OF AMENDMENT 2 OF THE SUBRECIPIENT AGREEMENT WITH INTERFAITH FOOD MINISTRY (IFM) EXTENDING THE EXPIRATION DATE THROUGH APRIL 5, 2024, WITH NO CHANGE TO THE MAXIMUM AMOUNT OF THE CONTRACT (RES. 21-414) (RES. 23-008)

WHEREAS, in an effort to reduce senior hunger and food insecurity within Nevada County, the Health and Human Service Agency through its Housing and Community Services Division (HCS) was awarded Community Development Block Grant 20-CDBG-12045 allocating \$465,000 to IFM in order to reduce food insecurity in Nevada County; and

WHEREAS, on September 14, 2021, per Resolution 21-414, the Nevada County Board of Supervisors approved a sub-recipient agreement by and between the County and IFM to provide nutritional support to the County's low-income sector of the community; and

WHEREAS, due to ongoing supply chain delays the parties wish to amend the sub-recipient agreement extending the expiration date under the agreement to ensure the community receives the full benefit of the program.

NOW, THEREFORE, BE IT RESOLVED that the Nevada County Board of Supervisors, of the County of Nevada, State of California, hereby directs that that Amendment 2 of the Subrecipient Agreement by and between the County of Nevada and the Interfaith Food Ministry awarding CDBG funds in the maximum amount of \$465,000, through April 5, 2024, to provide nutritional support to benefit low income individuals and families plagued by food insecurity, be and is hereby is approved in substantially the same form attached hereto, and that the Director of Housing and Community Services is authorized to execute the Amendment on behalf of the County of Nevada.



**AMENDMENT NO. 2 TO THE SUBRECIPIENT
AGREEMENT BETWEEN THE COUNTY OF NEVADA
AND INTERFAITH FOOD MINISTRY**

THIS AMENDMENT is dated this January 9, 2024 by and between the County of Nevada (herein called the “Grantee”) and Interfaith Food Ministry (herein called the “Subrecipient”). Said Amendment will amend the prior Agreement between the parties entitled Subrecipient Agreement, executed on September 14, 2021, per Resolution No. 21-414 and Amended on January 10, 2023, per Resolution 23-008.

WHEREAS, the parties desire to amend their agreement to amend the expiration date from December 31, 2023 to April 5, 2024, with no increase in the maximum contract amount of \$465,000, due to supply chain delays.

NOW, THEREFORE, the parties hereto agree as follows:

- 1) That Amendment No. 2 shall be effective as of December 7, 2023.
- 2) The expiration date is extended from December 31, 2023, to April 5, 2024.
- 3) That the Maximum Contract Amount shall remain \$465,000.
- 4) That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
