OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING EXECUTION OF THE OPERATIONAL AGREEMENT BETWEEN THE COUNTY OF NEVADA AND SIERRA NEVADA MEMORIAL-MINERS HOSPITAL PERTAINING TO THE PROVISION OF CRISIS STABILIZATION SERVICES ON THE SIERRA NEVADA MEMORIAL-MINERS HOSPITAL CAMPUS

WHEREAS, as a result of SB 82, known as the Investment in Mental Health Wellness Act of 2013, California has an opportunity to expand crisis support services that are expected to improve outcomes for the individuals served and to lead to improved system outcomes for local communities and their community partners; and

WHEREAS, the County was a successful applicant for funding from the California Health Facilities Financing Authority (CHFFA), which in partnership with Sierra Nevada Memorial-Miners Hospital (SNMH), will be used to develop a four-bed Crisis Stabilization Unit (CSU); and

WHEREAS, per Resolution 14-217, the Board of Supervisors accepted funding and approved the execution of the California Health Facilities Financing Authority (CHFFA) Investment in Mental Health Wellness Grant Agreement Number NV-01 for the development of the County's first Crisis Stabilization Unit; and

WHEREAS, the purpose of this Operational Agreement is to delineate the roles and responsibilities of the County and the Hospital and to establish the financial arrangement between the parties related to operation of the CSU; and

WHEREAS, the CSU will provide an essential resource for Nevada County families and community partners, and will serve as an alternative option to longer, more expensive inpatient psychiatric hospitalization services; and will enable mental health consumers to stabilize in a safe, secure community-based environment.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Operational Agreement by and between the County and Sierra Nevada Memorial-Miners Hospital delineating the respective roles and responsibilities and establishing the financial arrangement between the parties related to the operation of the Crisis Stabilization Unit, with the County agreeing to pay Sierra Nevada Memorial-Miners Hospital in the amount of \$302,615 for the first year of operation for services purchased from Sierra Nevada Memorial-Miners Hospital, and the Sierra Nevada Memorial-Miners Hospital agreeing to pay the County \$240,000 for the first year of operation for three (3) dedicated CSU beds, with the payment obligations of each party to be revised annually based on actual project costs and revenue, for the agreement term commencing as of the date of full execution remaining in effect until June 30, 2035, be and hereby is approved in substantially the form attached hereto, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Agreement on behalf of the County of Nevada.
