Public hearing to consider the application of the County of Nevada to adopt the Soda Springs Area Plan (Project) which includes the following actions: 1) amend the Nevada County General Plan to adopt the Soda Springs Area Plan (GP14-003); 2) amend the General Plan Land Use Map designations of 51 specific parcels to remove development constraints that inhibit desired economic growth in order to create a stronger community for local residents (GP16-004); 3) rezone parcels to align with the proposed land use designation amendments, including adding the Site Performance (SP) and Rural Center (RC) Combining District overlays to specific parcels (Z16-005); 4) amend Sec. L-II 4.2.3 of the Nevada County Zoning Ordinance to adopt the Soda Springs Area Plan design and development standards (ORD14-002); and 5) adopt the Negative Declaration for the Project (EIS14-004).
