SUBJECT: Award of Contract for the Nevada City Highway Sidewalk Extension

Project, County Contract No. 229622, and Amend the Fiscal Year 2016/17

Department of Public Works Capital Improvement Budget – 4/5

Affirmative Vote Required – Districts 1 and 3

RECOMMENDATION: Approve the attached Resolution.

<u>FUNDING</u>: Funding is provided through Congestion Mitigation and Air Quality (CMAQ) funds. A Fiscal Year 2016/17 budget amendment has been prepared for consideration; there is no impact to the County's General Fund.

BACKGROUND:

On January 24, 2017 the Nevada County Board of Supervisors adopted Resolution No. 17-054 that approved the plans, specifications and cost estimate for the subject project and instructed the Clerk of the Board of Supervisors to advertise for bids. The bids were opened on April 6, 2017, at 3:00 p.m. and are listed below:

Award is recommended for the contract work to the low bidder, Central Valley Engineering & Asphalt, Inc. at the bid price of \$481,204.00. The total amount to be encumbered is \$529,324.40, which includes a 10 percent contingency. Funds are available for the project. This contract provides placement for the final section of sidewalk and a class II bike lane along Nevada City Highway connecting the communities of

Nevada City and Grass Valley. Construction is scheduled to begin in July, and be completed within 35 working days, as allowed for in the contract.
