SUBJECT: Resolution approving execution of Amendment #1 to the renewal contract with Community Recovery Resources (CoRR) to provide substance abuse treatment services for Adult Drug Court Participants in their recovery from alcohol/drug dependency, to increase the contract maximum amount from \$139,251 to \$164,251 (an increase of \$25,000) for Fiscal Year 2016/17.

RECOMMENDATION: Approve the attached Resolution.

FUNDING: Contract services are funded through state 2011 Realignment funds allocated for Drug Courts services and SAMHSA funding made available through Probation. Services are within the Department's FY 2016/17 budget; therefore, a budget amendment is not required. There are no county general fund dollars required in the Agreement.

BACKGROUND: Per Resolution 16-439, the Board of Supervisors approved the renewal contract for Fiscal Year 2016/17 for Community Recovery Resources (CoRR) to provide alcohol/drug treatment services to Adult Drug Court clients for the County's Behavioral Health Department.

Adult Drug Court in Nevada County provides direct court supervision, regular drug testing, substance abuse treatment services (both residential and outpatient) and treatment activities. This is provided through collaboration between the Probation Department, the Court, the Public Defender's Office, the District Attorney's Office, the Behavioral Health Department and contracted providers.

The contract services include inpatient treatment, outpatient treatment, transitional housing, and ancillary services such as: Life Skills, Anger Management, Parenting Skills, Family Support, Relapse Prevention, and Literacy Skills. This contract allows participants of Adult Drug Court the options of inpatient treatment, an outpatient treatment alternative and a residential after-care program.

It is recommended that the Board approve this Amendment which increases the maximum contract amount, due to an unanticipated increase in services, as this contract supports the mission of drug court to stop the abuse of drugs and related criminal activity.
