### RESOLUTION APPROVING EXECUTION OF AMENDMENT NO. 1 TO THE RENEWAL PERSONAL SERVICES CONTRACT WITH THOMAS R. GRIFFITH, MFT (PESK3124)

WHEREAS, the County of Nevada entered into a Contract with Thomas R. Griffith, MFT, for the provision of specialty mental health services to Nevada County's Medi-Cal beneficiaries for referred County clients executed on July 5, 2016 per Purchase Order Number PESK3124; and

WHEREAS, the parties desire to amend their Agreement to increase the maximum contract price due to an unanticipated increase in services.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Amendment No. 1 to the Personal Services Contract by and between the County and Thomas R. Griffith, MFT, pertaining to increasing the maximum amount from \$25,000 to \$35,000 (an increase of \$10,000) for the provision of specialty mental health services including assessments/evaluations, plan development, therapy-individual, family, group or collateral for the term of July 1, 2016 through June 30, 2017 be and hereby is approved, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada.

**AMENDMENT #1 TO THE RENEWAL CONTRACT WITH THOMAS R.  
GRIFFITH, MFT (PESK3124)**

**THIS AMENDMENT** is dated this 27<sup>th</sup> day of March, 2017 by and between THOMAS R. GRIFFITH, MFT and COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties entitled Personal Services Contract executed on July 5<sup>th</sup>, 2016 by Purchase Order No. PESK3124.

**WHEREAS**, the parties desire to amend their agreement to increase the maximum contract price from \$25,000 to \$35,000 (an increase of \$10,000) due to an unanticipated increase in services.

**EXHIBIT "B"**  
**SCHEDULE OF CHARGES AND PAYMENTS**  
**THOMAS R. GRIFFITH, MFT**

As compensation for services rendered to County, Contractor shall be reimbursed for services which are pre-authorized by Nevada County Behavioral Health in accordance with Scope of Work and contractor's professional licensure.

The maximum contract price of this Agreement shall not exceed \$35,000 for the contract term.

Contractor agrees to accept these payments as payments in full and may not bill the client any additional fees. Contractor may not bill client for failure to show for an appointment. Rates of compensation and maximum length of time per service by Service Code are as follows:

**Rate Schedule:**

Service Code 100 - Assessment rate shall be Seventy Five Dollars (\$75.00) per 60 minute session.

Service Code 111 – Plan Development rate shall be \$50 per Service Plan hour.

Service Code 107 - Individual Therapy rate shall be Fifty Dollars (\$50.00) per 60 minute session.

Service Code 108 - Group Therapy - rate shall be Fifty Dollars (\$50.00) per 60 minute session.

Service Code 105 - Collateral rate shall be Fifty Dollars (\$50.00) per 60 minute session.

Payment to Contractor shall be made within thirty (30) after County's Behavioral Health Department has approved payment of the invoice.
