



RESOLUTION No. 13-537

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AND AUTHORIZING THE NEVADA COUNTY PUBLIC HEALTH DEPARTMENT TO INCREASE FEES RELATED TO ISSUANCE OF CERTIFIED COPIES OF VARIOUS VITAL RECORDS EFFECTIVE AS OF JANUARY 1, 2014

WHEREAS, effective January 1, 2014 various vital record fees will increase pursuant to Assembly Bill (AB) 1053, (Gordon, Chapter 402, Statutes of 2011) and AB 110, (Blumenfield, Chapter 20, Statutes of 2013); and

WHEREAS, the fees charged for providing certified copies of birth and death records have not kept pace with the true costs of providing certified copies of those records; and

WHEREAS, Sections 5 and 6 of AB 1053 address those deficiencies by raising the fees charged for those records to a level that more accurately reflect the true costs incurred; and

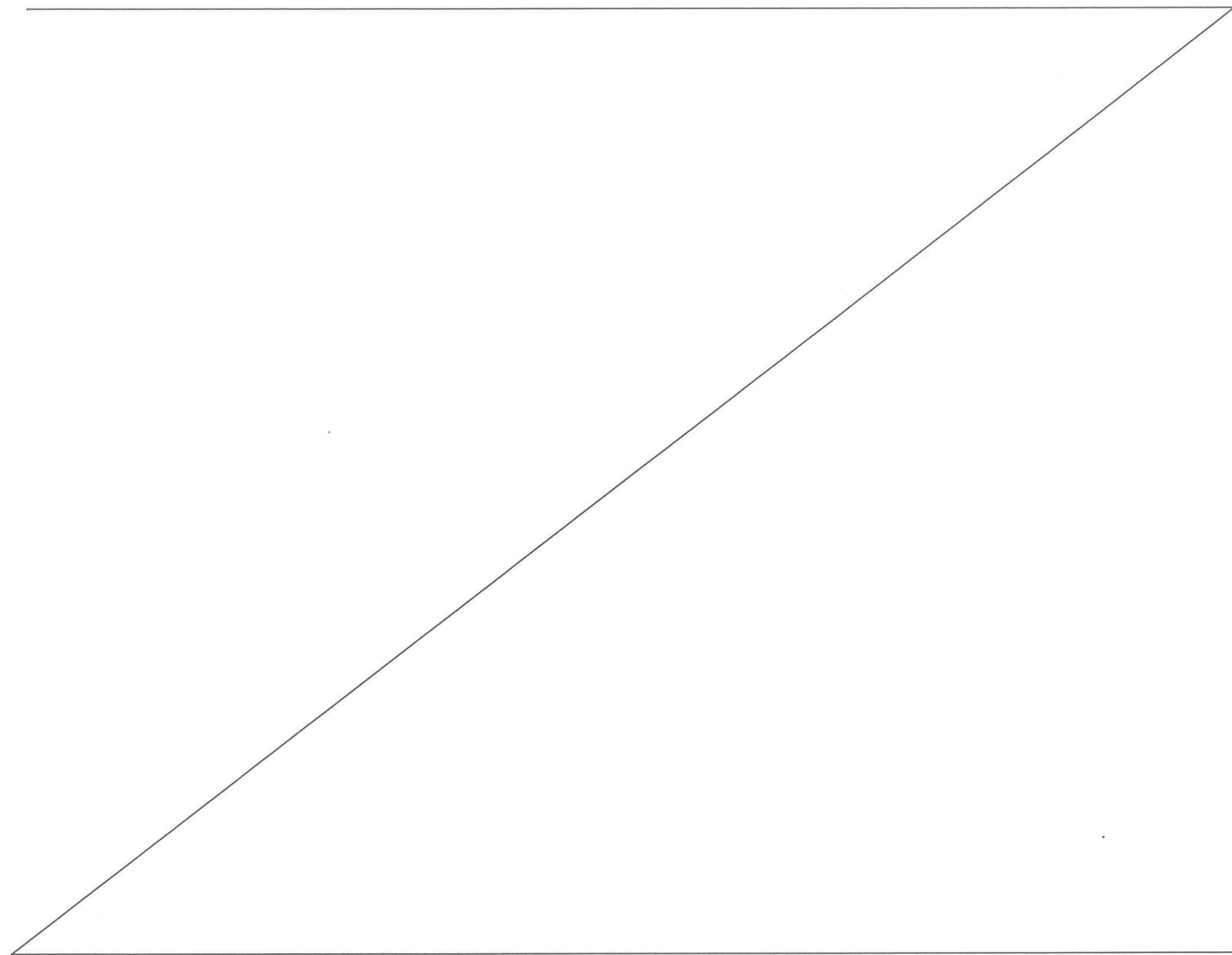
WHEREAS, the fees charged for the issuance of certified birth and death records are to be adjusted annually by the formula set forth in Section 100425 of the Health and Safety Code; and

WHEREAS, the following table shows the Public Health Fees that will be impacted as of January 1, 2014:

Certificate Category	Current Fee	AB 1053 Increase	AB 110 Increase	New Fee
Birth Certificates- General Public	\$20.00	\$2.00	\$3.00	\$25.00
Death Certificates- General Public & Governmental Agency	\$16.00	\$2.00	\$3.00	\$21.00
Fetal Death- General Public & Governmental Agency	\$13.00	\$2.00	\$3.00	\$18.00
Disposition of Human Remains	\$11.00		\$1.00	\$12.00

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Board of Supervisors of the County of Nevada, State of California, approves and authorizes the Nevada County Public Health Department to increase fees related to issuance of certified copies of various vital records effective as of January 1, 2014; and

FURTHERMORE, the Board approves and authorizes that the fees charged for the issuance of certified birth and death records are to be adjusted annually by the formula set forth in Section 100425 of the Health and Safety Code.
