
WHEREAS, the maximum amount of the contract was set at \$25,000; and,

WHEREAS, the parties desire to amend the Personal Services Agreement to increase the contract amount by \$40,000, for a Maximum Contract Price of \$65,000.

## AMENDMENT NO. 1 TO PERSONAL SERVICES CONTRACT WITH PORTER SCOTT, A PROFESSIONAL CORPORATION

THIS AMENDMENT No. 1 is made and is effective as of May 1, 2014, by and between Porter Scott, A Professional Corporation ("Contractor"), and the County of Nevada ("County"). This Amendment No. 1 amends the Personal Services Contract between the parties for legal services, effective as of January 1, 2014 ("Agreement").

WHEREAS, the parties entered into an agreement to provide County with legal representation of Nevada County and any Nevada County employees and officers that may be named as defendants in connection with claims filed by William and Yvonne Evans and related litigation, with a Maximum Contract Amount of \$25,000; and,

WHEREAS, the County desires that Contractor provide it with additional legal services related to the continued defense of this case, and Contractor is ready, willing and able to provide such services; and,

WHEREAS, the parties now desire to increase the maximum amount of the contract by \$40,000, to a Maximum Contract Amount of \$65,000, to pay for the additional legal services.

NOW, THEREFORE, in consideration of the mutual promises and agreements contained herein, the parties hereto agree as follows:

- 1. That Section 2, Maximum Contract Amount, is hereby increased from \$25,000 to \$65,000.
- 2. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
