## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

## APPROVING AMENDMENT NO. 4 TO THE PERSONAL SERVICES CONTRACT BETWEEN THE COUNTY OF NEVADA AND ANDREGG PSOMAS (PREVIOUSLY ANDREGG GEOMATICS) FOR PROFESSIONAL LAND SURVEYING SERVICES FOR VARIOUS CAPITAL IMPROVEMENT PROJECTS AND ROAD MAINTENANCE ACTIVITIES

WHEREAS, on July 22, 2014, the Nevada County Board of Supervisors adopted Resolution 14-359, which awarded the subject contract to Andregg Geomatics for professional land surveying services for various capital improvement projects and road maintenance activities with the contact amount not to exceed \$75,000; and

WHEREAS, the Resolution awarded a one-year contract that may be amended annually for a total maximum contract period of five (5) years; and

WHEREAS, the contract has since been extended three times and currently has an expiration date of June 30, 2018; and

WHEREAS, recently Andregg Geomatics was acquired by Andregg Psomas; and

WHEREAS, Andregg Geomatics has requested that the County accept an assignment of contract and amend the existing contract to reflect the recent acquisition.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Nevada County Board of Supervisors that Amendment No. 4 to the Personal Services Contract by and between the County of Nevada and Andregg Psomas, be and hereby is approved in the form attached hereto, and that the Chair of the Board of Supervisors is hereby authorized to execute the Amendment on behalf of the County.

## AMENDMENT NO. 4 TO THE CONTRACT WITH ANDREGG PSOMAS (previously Andregg Geomatics)

THIS AMENDMENT NO. 4 is executed this <u>N</u><sup>th</sup> day of <u>December</u>, 2017, by and between ANDREGG PSOMAS (previously Andregg Geomatics) and COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties entitled Contract for Professional Surveying Services for Various Capital Improvement Projects and Road Maintenance Activities executed on July 22, 2014, by Resolution No. 14-359; Amendment No. 1 executed on June 16, 2015 by Resolution No. 15-266; Amendment No. 2 executed on June 21, 2016 by Resolution 16-278; and Amendment No. 3 executed on June 20, 2017 by Resolution 17-320. Resolution 14-359 provided for award of contract to ANDREGG PSOMAS (previously Andregg Geomatics) the amount of \$75,000.

WHEREAS, the parties desire to amend the Contract to reflect the recent acquisition of Andregg Geomatics by ANDREGG PSOMAS.

NOW, THEREFORE, in consideration of the mutual promises and agreements contained herein, the parties hereto agree as follows:

- 1. That the Board of Supervisors approves an assignment of contract and accepts Andregg Psomas in place of Andregg Geomatics for all future services to be provided by the Contract.
- 2. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.


