OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION DETERMINING THE CANNABIS COMMUNITY ADVISORY GROUP'S (CAG) PROCESS FOR GATHERING COMMUNITY INPUT FOR THE COUNTY'S LONG-TERM CANNABIS CULTIVATION REGULATIONS AS COMPLETE AND DISSOLVING THE CAG

WHEREAS, the Board of Supervisors expressed a desire to engage in a community stakeholder process to gather input from a broad spectrum of Nevada County citizens regarding the development of long-term regulations related to cannabis cultivation and other cannabis-related activities; and

WHEREAS, on April 11, 2017, by Resolution 17-169, the Board of Supervisors approved a contract with MIG, Inc.; and

WHEREAS, a task within the scope of the MIG contract was to assist the County in developing a Cannabis Community Advisory Group for the purpose of gathering community input; and

WHEREAS, on April 25, 2017 the Board of Supervisors, by Resolution 17-193 approved the CAG selection criteria; and

WHEREAS, on May 9, 2017 the Board of Supervisors, by Resolution 17-296 selected 16 members to serve on the CAG; and

WHEREAS, beginning on May 23, 2017 and ending on December 19, 2017, the CAG held ten public meetings and received input for the County's long-term cannabis cultivation regulations; and


WHEREAS, the CAG process is a portion of the larger process to develop the County's long-term cannabis cultivation regulations; and

WHEREAS, a task within the scope of the MIG contract was to prepare a recommendation report from the CAG capturing the input and summarizing the discussions of the CAG members; and

WHEREAS, the public and those who served on the CAG will have additional opportunities at future Board of Supervisors meetings to provide input on the County's long-term cannabis cultivation regulations.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Board of Supervisors of the County of Nevada received the CAG's recommendation report prepared and presented by MIG.and determines the CAG process complete.

BE IT FURTHER RESOLVED that the Board of Supervisors of the County of Nevada thanks the CAG members for their input, dedication, and service; releases the CAG appointees; and dissolves the CAG determining the CAG portion of the cannabis cultivation regulation development process complete.
