

WHEREAS, said Contract was for the 2017 Nevada County Annual Striping Program Phase 1 and Phase 2 and was constructed in accordance with the plans and specifications; and

WHEREAS, the improvements were completed to the satisfaction of Nevada County Department of Public Works on December 8, 2017 with contract costs totaling \$217,914.60.


