RESOLUTION APPROVING THE GOVERNOR'S OFFICE OF EMERGENCY SERVICES (Cal OES) GRANT AWARD XC16010290 AMENDMENT NO. 1 FOR THE NEVADA COUNTY VICTIM SERVICES PROGRAM FOR THE PERIOD OF JULY 1, 2016 to DECEMBER 31, 2019

WHEREAS, the Board of Supervisors approved the California Office of Emergency Services (Cal OES) Grant Award XC16010290 in the amount of \$197,979 for the term of July 1, 2016 to June 30, 2018 per Resolution 16-516; and

WHEREAS, the California Office of Emergency Services (Cal OES) has awarded Amendment No. 1 to the County of Nevada District Attorney's Office additional Federal Victim of Crime Act (VOCA) funds in the amount of \$143,809 for a total of \$341,788 in Federal VOCA funds, and total project costs including match funds to \$427,235 for the extended term of July 1, 2016 to December 31, 2019; and

WHEREAS, any liability arising out of the performance of a XC Victim Services Program Grant Award Agreement, including civil court actions for damages, shall be the responsibility of the grant recipients and the authorizing agency. The State of California and Cal OES disclaim responsibility for such liability; and

WHEREAS, the grant funds received hereunder shall not be used to supplant existing expenditures controlled by this body.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Nevada, State of California accepts the Cal OES Grant Amendment No. 1, extending the grant term to December 31, 2019. Additional grant funds received in the amount of \$143,809 for said project shall be deposited into the District Attorney Revenue Account 0101 50608 203 1000 446700.


