

# RESOLUTION No. 18-133

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION AUTHORIZING AMENDMENT OF A PERSONAL SERVICES CONTRACT BETWEEN THE COUNTY OF NEVADA AND VAN DERMYDEN MADDUX LAW CORPORATION AND BUDGET AMENDMENT OF THE FISCAL YEAR 2017/18 HUMAN RESOURCES BUDGET (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, this amendment is executed this 10<sup>th</sup> day of April, 2018 by and between VAN DERMYDEN MADDUX LAW CORPORATION and COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties dated January 25, 2018 executed by the County Purchasing Agent for administrative investigative services, PESL3499; and

WHEREAS, the County wishes to convert this to a Board approved contract for payment to the vendor from budget 0101-10401-641-2000 521520; and

WHEREAS, the parties desire to amend their agreement to increase the contract amount from \$15,000 to \$65,000, to allow for further services to be provided.


## NOW, THEREFORE, BE IT HEREBY RESOLVED that the Board of Supervisors:

- 1. Approves Amendment One to the Contract with Van Dermyden Madduux Law Corporation found in Exhibit A, attached, and authorizes the Chair of the Board of Supervisors to execute the amended Contract; and
- 2. Directs the Auditor-Controller to modify the Human Resources budget for the Fiscal Year 2017/18 year as follows:

0101-10401-641-2000 561063 Interfund Reimbursement by \$50,000

### AMENDMENT TO CONTRACT WITH VAN DERMYDEN MADDUX

THIS AMENDMENT is executed this 10th day of April, 2018 by and between VAN DERMYDEN MADDUX and COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties entitled Personal Services Contract executed on January 1, 2018 by the County Purchasing Agent.

**WHEREAS**, the parties desire to amend their agreement to allow or provide for additional administrative investigative services to be conducted; and

NOW, THEREFORE, the parties hereto agree as follows:

- 1. This amendment shall be effective as of January 1, 2018.
- 2. That paragraph §2 shall be changed to the following: \$65,000
- 3. That the Schedule of Charges, Exhibit "B" shall be amended by adding the following fee schedule for work performed in 2018:

Services provided in calendar year 2018 will be provided to the County according to the fee schedule below:

- 1. The fees for services provided to the County of Nevada pursuant to this agreement will be calculated and billed at \$425 per hour for Senior Partner time, \$350 for Partner time, \$290 per hour for Senior Associate time, \$250 for Associate time, \$175 for Law Clerk time, and \$120 per hour for paralegal time. In addition, the County will pay reasonable and necessary travel expenses. Mileage will be billed at federal standard mileage rate in effect at the time of travel.
- 2. The Contractor will send the County of Nevada monthly statements for fees and costs incurred. Each statement will be payable within 30 days of its date. Invoices must be paid within 30 days.
- 4. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
