RESOLUTION APPROVING EXECUTION OF STANDARD AGREEMENT NUMBER 17-94081 WITH THE CALIFORNIA DEPARTMENT OF HEALTH CARE SERVICES FOR THE PURPOSE OF IDENTIFYING AND PROVIDING DRUG MEDI-CAL ORGANIZED DELIVERY SYSTEM (DMC-ODS) SERVICES FOR SUBSTANCE USE DISORDER TREATMENT AND AUTHORIZING AND DIRECTING THE AUDITOR-CONTROLLER TO AMEND THE BEHAVIORAL HEALTH DEPARTMENT'S BUDGET FOR FISCAL YEAR 2017/18 (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, on August 13, 2015 the Center for Medicare and Medicaid Services (CMS) approved the request to amend California's section 1115 Demonstration Project, entitled California Bridge to Reform Demonstration; and

WHEREAS, this amendment authorizes the state to test a new organized delivery of health care services for Medicaid eligible individuals with a substance use disorder (SUD); and

WHEREAS, the Drug Medi-Cal Organized Delivery System (DMC-ODS) provides a continuum of care modeled after the American Society of Addiction Medicine Criteria for SUD treatment services, enables more local control and accountability, provides greater administrative oversight, creates utilization controls to improve care and efficient use of resources, implements evidenced based practices in substance abuse treatment, and coordinates with other systems of care; and

WHEREAS, Nevada County submitted its DMC-ODS Implementation Plan to the Department of Health Care Services which outlines the treatment services available to eligible Nevada County Medi-Cal Beneficiaries including outpatient, withdrawal management, residential, opioid/narcotic treatment, recovery, and case management and the Implementation Plan was subsequently approved on 10/26/17; and

WHEREAS, Nevada County also submitted its DMC-ODS Fiscal Plan, which received state approval on 3/13/18; and

WHEREAS, this Agreement will allow Nevada County to ensure that Nevada County's Medi-Cal beneficiaries have access to a complete array of SUD services to support recovery; and

WHEREAS, participation in the DMC-ODS will also allow Nevada County to fully utilize the capacity of the recently re-opened Bost House.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Standard Agreement Number 17-94081 by and between the County and the California Department of Health Care Services for the purpose of identifying and providing Drug Medi-Cal Organized Delivery System (DMC-ODS) services for substance use disorder (SUD) treatment in Nevada County in the maximum amount of \$9,731,263 for the term of June 28, 2018 through June 30, 2020, be and hereby is approved in substantially the form attached hereto, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Agreement on behalf of the County of Nevada.

Funds to be deposited into revenue account 1589-40105-493-7831/446250.

BE IT FURTHER RESOLVED that the Nevada County Board of Supervisors authorizes and directs the Auditor-Controller to amend the Behavioral Health Department's Budget for Fiscal Year 2017/18 as follows:
