WHEREAS, the County of Nevada entered into a Standard Public Works Contract with Steve A. Owens dba Owens Construction (44 Leonard Lane, Applegate, California, 95703) per Resolution 17-534, totaling \$25,850, including a 10% contingency; and

WHEREAS, said Contract was for the Bost House ADA Parking and Entry Ramp Project in accordance with the plans and specifications; and

WHEREAS, Resolution 18-058 amended the contract to extend the completion date to May 15, 2018 to allow for asphalt sealing and striping that could not be done in wet weather; and


WHEREAS, Behavioral Health has obtained grant funding for additional improvements to the Bost House that will include the asphalt sealing and striping; and
